Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 979, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE ENVIRONMENT,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to temporarily authorize funds from the Special Land and Development Fund and the Land Conservation Fund to be used for invasive species control and mitigation, reforestation, and sediment run-off mitigation.

Your Committee on Conference has amended this bill by:


- (1) Changing the effective date to July 1, 2010; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.




