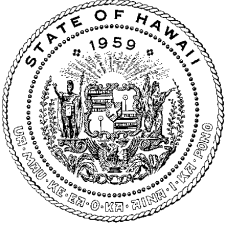
Your prompt response in providing the requested information will ensure that the Senate confirmation process can proceed in a timely manner.

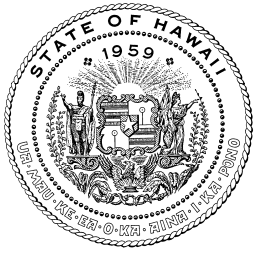
