S.B. NO. 167

A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide
2 procurement authority to semi-autonomous county public transit
3 agencies, including the agency known as the Honolulu Authority
4 for Rapid Transportation, by authorizing the directors of the
5 semi-autonomous public transit agencies of the respective
6 counties to serve as chief procurement officers.

7 SECTION 2. Section 103D-203, Hawaii Revised Statutes, is
8 amended by amending subsections (b) and (c) to read as follows:

9 "(b) The chief procurement officers for each of the
10 several counties shall be:

11 (1) The executive branch--the respective finance directors
12 of the several counties, except as provided in
13 paragraphs (3) [~~and~~], (4) [~~+~~], and (5);

14 (2) The legislative branch--the respective chairpersons of
15 the councils of the several counties;

16 (3) The Honolulu, Kauai, and Maui boards or departments of
17 water supply--the managers and chief engineers of the



1 respective boards or departments of water supply as
2 designated by county charter; [~~and~~]

3 (4) The Hawaii board of water supply--the manager of the
4 board of water supply as designated by county charter;
5 and

6 (5) The semi-autonomous public transit agencies--the
7 director of the respective agency as designated by
8 county charter;

9 provided that the chief procurement officers designated under
10 paragraphs (1), (2), (3), [~~and~~] (4), and (5) shall not exercise
11 their powers or duties over contracting in a manner contrary to
12 the respective county's charter, ordinances, or rules adopted in
13 accordance with chapter 91.

14 (c) For purposes of applying this chapter to the
15 judiciary, houses of the legislature, office of Hawaiian
16 affairs, University of Hawaii, department of education,
17 remaining departments of the executive branch and all
18 governmental bodies administratively attached to them, and the
19 several counties, unless otherwise expressly provided, "State"
20 shall mean "judiciary", "state senate", "state house of
21 representatives", "office of Hawaiian affairs", "University of
22 Hawaii", "department of education", "executive branch",



1 "county", [~~and~~] "board of water supply" [~~7~~] or "department of
2 water supply", and "semi-autonomous public transit agency",
3 respectively."

4 SECTION 3. Statutory material to be repealed is bracketed
5 and stricken. New statutory material is underscored.

6 SECTION 4. This Act shall take effect upon its approval.
