
A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the national and
2 global economic crisis that began in the second half of 2008 has
3 caused significant economic problems in numerous industries in
4 the State, including the airline, cruise ship, tourist, and
5 construction industries. Mass layoffs have been reported by an
6 increasing number of Hawaii businesses statewide, from the
7 agricultural sector to the medical-services sector. Difficult
8 economic times and declining tax revenues have resulted in
9 budget cuts for all state services.

10 The current and impending situation jeopardizes the safety
11 net of basic human services, health, and education needs for
12 Hawaii's residents and families. While all of Hawaii's
13 residents will be affected by the situation, gap group families
14 and families closest to the poverty line will suffer the most.

15 Pursuant to Act 304, Session Laws of Hawaii 1999, the
16 legislature established the emergency and budget reserve fund,
17 which is codified in section 328L-3, Hawaii Revised Statutes, as
18 a temporary supplemental source of funding for the State of



1 Hawaii in times of emergency, economic downturn, or unforeseen
2 reduction in revenues. As set forth in section 328L-3, Hawaii
3 Revised Statutes, specific purposes for the fund include
4 maintaining levels of programs determined to be essential to
5 public health, safety, welfare, and education. Section 328L-3,
6 Hawaii Revised Statutes, also includes certain prohibitions on
7 appropriations from the emergency and budget reserve fund.
8 Appropriations for the following purposes are specifically
9 prohibited:

- 10 (1) To meet expenses of the legislature;
- 11 (2) To provide for salary adjustments for officials
12 appointed pursuant to article V, section 6; or article
13 VI, section 3, of the Hawaii State Constitution and
14 for others whose salaries are directly related to
15 salaries of these officials; and
- 16 (3) To fund cost items in any collective bargaining
17 contract.

18 The legislature finds that expenditures from the emergency
19 and budget reserve fund are needed to meet the conditions of
20 emergency, economic downturn, and unforeseen reduction in
21 revenues that the State currently faces. Further, the
22 legislature finds that the appropriations in this Act are



1 consistent with the purposes of the emergency and budget reserve
2 fund.

3 The purpose of this Act is to appropriate moneys from the
4 emergency and budget reserve fund of the State of Hawaii to
5 maintain the levels of programs determined to be essential to
6 education, public health, and public welfare.

7 SECTION 2. There is appropriated out of the emergency and
8 budget reserve fund of the State of Hawaii the sum of \$
9 or so much thereof as may be necessary for fiscal year 2011-2012
10 for respite services.

11 The sum appropriated shall be expended by the department of
12 health for the purposes of this Act.

13 SECTION 3. There is appropriated out of the emergency and
14 budget reserve fund of the State of Hawaii the sum of \$
15 or so much thereof as may be necessary for fiscal year 2011-2012
16 to supplement the healthy start program.

17 The sum appropriated shall be expended by the department of
18 health for the purposes of this Act.

19 SECTION 4. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012



1 to provide funding for grants pursuant to chapter 42F, Hawaii
2 Revised Statutes, to Waikiki Community Center.

3 The sum appropriated shall be expended by the department of
4 health for the purposes of this Act.

5 SECTION 5. There is appropriated out of the emergency and
6 budget reserve fund of the State of Hawaii the sum of \$
7 or so much thereof as may be necessary for fiscal year 2011-2012
8 for the kupuna care program.

9 The sum appropriated shall be expended by the department of
10 health for the purposes of this Act.

11 SECTION 6. There is appropriated out of the emergency and
12 budget reserve fund of the State of Hawaii the sum of \$
13 or so much thereof as may be necessary for fiscal year 2011-2012
14 for the Aging and Disability Resource Center.

15 The sum appropriated shall be expended by the department of
16 health for the purposes of this Act.

17 SECTION 7. There is appropriated out of the emergency and
18 budget reserve fund of the State of Hawaii the sum of \$
19 or so much thereof as may be necessary for fiscal year 2011-2012
20 for the developmental disabilities medicaid waiver program.

21 The sum appropriated shall be expended by the department of
22 health for the purposes of this Act.



1 SECTION 8. There is appropriated out of the emergency and
2 budget reserve fund of the State of Hawaii the sum of \$
3 or so much thereof as may be necessary for fiscal year 2011-2012
4 for mental health services.

5 The sum appropriated shall be expended by the department of
6 health for the purposes of this Act.

7 SECTION 9. There is appropriated out of the emergency and
8 budget reserve fund of the State of Hawaii the sum of \$
9 or so much thereof as may be necessary for fiscal year 2011-2012
10 for the partnerships in community living program.

11 The sum appropriated shall be expended by the department of
12 health for the purposes of this Act.

13 SECTION 10. There is appropriated out of the emergency and
14 budget reserve fund of the State of Hawaii the sum of \$
15 or so much thereof as may be necessary for fiscal year 2011-2012
16 for substance abuse treatment.

17 The sum appropriated shall be expended by the department of
18 health for the purposes of this Act.

19 SECTION 11. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 for the healthy aging partnerships program.



1 The sum appropriated shall be expended by the department of
2 health for the purposes of this Act.

3 SECTION 12. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to provide funding for grants pursuant to chapter 42F, Hawaii
7 Revised Statutes, to the Waianae District Comprehensive Health
8 and Hospital Board, Inc., to support its emergency room
9 services.

10 The sum appropriated shall be expended by the department of
11 health for the purposes of this Act.

12 SECTION 13. There is appropriated out of the emergency and
13 budget reserve fund of the State of Hawaii the sum of \$
14 or so much thereof as may be necessary for fiscal year 2011-2012
15 to provide funding for grants pursuant to chapter 42F, Hawaii
16 Revised Statutes, for HIV/AIDS related services and to be
17 distributed as follows:

- 18 (1) Life Foundation \$
- 19 (2) Gregory House Programs \$
- 20 (3) Community Health Outreach Work to
- 21 Prevent AIDS Project \$



1 The sum appropriated shall be expended by the department of
2 health for the purposes of this Act.

3 SECTION 14. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to fund the housing first pilot program, through a collaboration
7 between the Hawaii public housing authority and the department
8 of human services, for chronically homeless individuals,
9 including those who have an addiction or mental illness, or
10 both.

11 The Hawaii public housing authority, in collaboration with
12 the department of human services shall prepare a report to the
13 legislature on the progress of the housing first pilot program.
14 The Hawaii public housing authority shall submit the report to
15 the legislature no later than twenty days prior to the convening
16 of the regular session of 2012.

17 The sum appropriated shall be expended by the department of
18 human services for the purposes of this Act.

19 SECTION 15. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 for meals for the elderly for kupuna care.



1 The sum appropriated shall be expended by the department of
2 health's executive office on aging for the purposes of this Act.

3 SECTION 16. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to provide funding for grants pursuant to chapter 42F, Hawaii
7 Revised Statutes, to Kokua Kalihi Valley (Comprehensive Family
8 Services).

9 The sum appropriated shall be expended by the department of
10 health for the purposes of this Act.

11 SECTION 17. There is appropriated out of the emergency and
12 budget reserve fund of the State of Hawaii the sum of \$
13 or so much thereof as may be necessary for fiscal year 2011-2012
14 to provide funding for grants pursuant to chapter 42F, Hawaii
15 Revised Statutes, to The Path Clinic for services to pregnant
16 women struggling with addiction.

17 The sum appropriated shall be expended by the department of
18 health for the purposes of this Act.

19 SECTION 18. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012



1 for the baby S.A.F.E. (substance abuse free environment)
2 program.

3 The sum appropriated shall be expended by the department of
4 health for the purposes of this Act.

5 SECTION 19. There is appropriated out of the emergency and
6 budget reserve fund of the State of Hawaii the sum of \$
7 or so much thereof as may be necessary for fiscal year 2011-2012
8 for fetal alcohol spectrum disorders.

9 The sum appropriated shall be expended by the department of
10 health for the purposes of this Act.

11 SECTION 20. There is appropriated out of the emergency and
12 budget reserve fund of the State of Hawaii the sum of \$
13 or so much thereof as may be necessary for fiscal year 2011-2012
14 for family planning.

15 The sum appropriated shall be expended by the department of
16 health for the purposes of this Act.

17 SECTION 21. There is appropriated out of the emergency and
18 budget reserve fund of the State of Hawaii the sum of \$
19 or so much thereof as may be necessary for fiscal year 2011-2012
20 for perinatal health programs.

21 The sum appropriated shall be expended by the department of
22 health for the purposes of this Act.



1 SECTION 22. There is appropriated out of the emergency and
2 budget reserve fund of the State of Hawaii the sum of \$
3 or so much thereof as may be necessary for fiscal year 2011-2012
4 for the preschool developmental screening program.

5 The sum appropriated shall be expended by the department of
6 health for the purposes of this Act.

7 SECTION 23. There is appropriated out of the emergency and
8 budget reserve fund of the State of Hawaii the sum of \$
9 or so much thereof as may be necessary for fiscal year 2011-2012
10 to provide funding for grants pursuant to chapter 42F, Hawaii
11 Revised Statutes, to the Blueprint for Change for neighborhood
12 place walk-in centers.

13 The sum appropriated shall be expended by the department of
14 human services for the purposes of this Act.

15 SECTION 24. There is appropriated out of the emergency and
16 budget reserve fund of the State of Hawaii the sum of \$
17 or so much thereof as may be necessary for fiscal year 2011-2012
18 to provide funding for grants pursuant to chapter 42F, Hawaii
19 Revised Statutes, to the Hawaii Primary Care Association for the
20 Hawaii immigrant health initiative program provided at federally
21 qualified health centers;



1 The sum appropriated shall be expended by the department of
2 human services for the purposes of this Act.

3 SECTION 25. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to provide funding for grants pursuant to chapter 42F, Hawaii
7 Revised Statutes, to support domestic violence shelters
8 statewide and to be distributed as follows:

- 9 (1) Child and Family Service
 - 10 (A) Two shelters on Oahu \$
 - 11 (B) Two shelters on Big Island \$
- 12 (2) Parents and Children Together \$
- 13 (3) Women Helping Women \$
- 14 (4) Molokai Community Service Council, Inc. \$
- 15 (5) Young Women's Christian
 - 16 Association (YWCA) of Kauai \$
- 17 (6) Windward Spouse Abuse Shelter \$
- 18 (7) Statewide domestic violence shelters \$

19 The sum appropriated shall be expended by the department of
20 human services for the purposes of this Act.

21 SECTION 26. There is appropriated out of the emergency and
22 budget reserve fund of the State of Hawaii the sum of \$



1 or so much thereof as may be necessary for fiscal year 2011-2012
2 to provide funding for grants pursuant to chapter 42F, Hawaii
3 Revised Statutes, to Hale Mahaolu for personal care services.

4 The sum appropriated shall be expended by the department of
5 human services for the purposes of this Act.

6 SECTION 27. There is appropriated out of the emergency and
7 budget reserve fund of the State of Hawaii the sum of \$
8 or so much thereof as may be necessary for fiscal year 2011-2012
9 for the shelter plus care program.

10 The sum appropriated shall be expended by the department of
11 human services for the purposes of this Act.

12 SECTION 28. There is appropriated out of the emergency and
13 budget reserve fund of the State of Hawaii the sum of \$
14 or so much thereof as may be necessary for fiscal year 2011-2012
15 to provide funding for grants pursuant to chapter 42F, Hawaii
16 Revised Statutes, to the Hawaii Primary Care Association for
17 adult dental care provided at federally qualified health
18 centers; provided that the funds shall not be used for any other
19 purpose. The governor is authorized to utilize enhanced federal
20 medical assistance percentages funds to offset the amount
21 appropriated; provided that the total amount shall not exceed



1 \$. The department of human services shall prepare a
2 report on:

- 3 (1) The number of adults receiving these benefits;
- 4 (2) The cost per person;
- 5 (3) Total breakdown of administrative costs and other
6 overhead costs; and
- 7 (4) Statistics, if available, on how this dental program
8 is reducing the number of emergency dental-related
9 medical procedures;

10 provided further that the department of human services shall
11 submit its report to the legislature no later than twenty days
12 prior to the convening of the 2012 regular session.

13 The sum appropriated shall be expended by the department of
14 human services for the purposes of this Act.

15 SECTION 29. There is appropriated out of the emergency and
16 budget reserve fund of the State of Hawaii the sum of \$
17 or so much thereof as may be necessary for fiscal year 2011-2012
18 for the Maui community college, University of Hawaii, for the
19 adult dental care program.

20 The sum appropriated shall be expended by the department of
21 human services for the purposes of this Act.



1 SECTION 30. There is appropriated out of the emergency and
2 budget reserve fund of the State of Hawaii the sum of \$
3 or so much thereof as may be necessary for fiscal year 2011-2012
4 to provide funding for grants pursuant to chapter 42F, Hawaii
5 Revised Statutes, to the Hawaii Primary Care Association for
6 outstationed eligibility worker services provided at federally
7 qualified health centers.

8 The sum appropriated shall be expended by the department of
9 human services for the purposes of this Act.

10 SECTION 31. There is appropriated out of the emergency and
11 budget reserve fund of the State of Hawaii the sum of \$
12 or so much thereof as may be necessary for fiscal year 2011-2012
13 to provide funding for grants pursuant to chapter 42F, Hawaii
14 Revised Statutes, to the Hawaii Primary Care Association for
15 outreach services provided at federally qualified health
16 centers.

17 The sum appropriated shall be expended by the department of
18 human services for the purposes of this Act.

19 SECTION 32. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 to provide funding for grants pursuant to chapter 42F, Hawaii



1 Revised Statutes, to the Hawaii Primary Care Association for
2 outreach services to locate uninsured children provided at
3 federally qualified health centers.

4 The sum appropriated shall be expended by the department of
5 human services for the purposes of this Act.

6 SECTION 33. There is appropriated out of the emergency and
7 budget reserve fund of the State of Hawaii the sum of \$
8 or so much thereof as may be necessary for fiscal year 2011-2012
9 for child care subsidies.

10 The sum appropriated shall be expended by the department of
11 human services for the purposes of this Act.

12 SECTION 34. There is appropriated out of the emergency and
13 budget reserve fund of the State of Hawaii the sum of \$
14 or so much thereof as may be necessary for fiscal year 2011-2012
15 for the general assistance program under section 346-71, Hawaii
16 Revised Statutes, to maintain the general assistance benefit
17 amount at \$ per person per month or as close to \$ per
18 person per month as possible, given the monthly caseload.

19 The sum appropriated shall be expended by the department of
20 human services for the purposes of this Act.

21 SECTION 35. There is appropriated out of the emergency and
22 budget reserve fund of the State of Hawaii the sum of \$



1 or so much thereof as may be necessary for fiscal year 2011-2012
2 to provide funding for grants pursuant to chapter 42F, Hawaii
3 Revised Statutes, to Adult Friends for Youth for youth gang
4 prevention and intervention services.

5 The sum appropriated shall be expended by the department of
6 human services for the purposes of this Act.

7 SECTION 36. There is appropriated out of the emergency and
8 budget reserve fund of the State of Hawaii the sum of \$
9 or so much thereof as may be necessary for fiscal year 2011-2012
10 to provide funding for grants pursuant to chapter 42F, Hawaii
11 Revised Statutes, to Hawaii Centers for Independent Living for
12 statewide independent living services.

13 The sum appropriated shall be expended by the department of
14 human services for the purposes of this Act.

15 SECTION 37. There is appropriated out of the emergency and
16 budget reserve fund of the State of Hawaii the sum of \$
17 or so much thereof as may be necessary for fiscal year 2011-2012
18 to provide funding for grants pursuant to chapter 42F, Hawaii
19 Revised Statutes, to the Susannah Wesley Community Center for
20 the Susannah Wesley Community Center Youth Service Center.

21 The sum appropriated shall be expended by the department of
22 human services for the purposes of this Act.



1 SECTION 38. There is appropriated out of the emergency and
2 budget reserve fund of the State of Hawaii the sum of \$
3 or so much thereof as may be necessary for fiscal year 2011-2012
4 to provide funding for grants pursuant to chapter 42F, Hawaii
5 Revised Statutes, to Planned Parenthood of Hawaii for statewide
6 sexual health education.

7 The sum appropriated shall be expended by the department of
8 human services for the purposes of this Act.

9 SECTION 39. There is appropriated out of the emergency and
10 budget reserve fund of the State of Hawaii the sum of \$
11 or so much thereof as may be necessary for fiscal year 2011-2012
12 to provide funding for grants pursuant to chapter 42F, Hawaii
13 Revised Statutes, to the Partners in Development Foundation to
14 provide comprehensive family training and transitional services
15 to homeless families on the leeward coast of Oahu and for the
16 Tutu and Me Traveling Preschool.

17 The sum appropriated shall be expended by the department of
18 human services for the purposes of this Act.

19 SECTION 40. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 for the preschool open doors program.



1 The sums appropriated shall be expended by the department
2 of human services for the purposes of this Act.

3 SECTION 41. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to provide funding for grants pursuant to chapter 42F, Hawaii
7 Revised Statutes, to Oahu About Face Family of Programs.

8 The sum appropriated shall be expended by the department of
9 human services for the purposes of this Act.

10 SECTION 42. There is appropriated out of the emergency and
11 budget reserve fund of the State of Hawaii the sum of \$
12 or so much thereof as may be necessary for fiscal year 2011-2012
13 for domestic violence services.

14 The sum appropriated shall be expended by the judiciary for
15 the purposes of this Act.

16 SECTION 43. There is appropriated out of the emergency and
17 budget reserve fund of the State of Hawaii the sum of \$
18 or so much thereof as may be necessary for fiscal year 2011-2012
19 to provide funding for grants pursuant to chapter 42F, Hawaii
20 Revised Statutes, to Volunteer Legal Services Hawaii to provide
21 pro bono legal services for indigent persons.



1 The sum appropriated shall be expended by the judiciary for
2 the purposes of this Act.

3 SECTION 44. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$
5 or so much thereof as may be necessary for fiscal year 2011-2012
6 to provide funding for grants pursuant to chapter 42F, Hawaii
7 Revised Statutes, to the Legal Aid Society of Hawaii to provide
8 general civil legal services.

9 The sum appropriated shall be expended by the judiciary for
10 the purposes of this Act.

11 SECTION 45. There is appropriated out of the emergency and
12 budget reserve fund of the State of Hawaii the sum of \$
13 or so much thereof as may be necessary for fiscal year 2011-2012
14 to provide funding for grants pursuant to chapter 42F, Hawaii
15 Revised Statutes, for the Hawaii Family Law Clinic to provide
16 services to obtain temporary restraining orders.

17 The sum appropriated shall be expended by the judiciary for
18 the purposes of this Act.

19 SECTION 46. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 to provide funding for grants pursuant to chapter 42F, Hawaii



1 Revised Statutes, to the Catholic Charities Hawaii to provide
2 intra-familial sex assault services.

3 The sum appropriated shall be expended by the judiciary for
4 the purposes of this Act.

5 SECTION 47. There is appropriated out of the emergency and
6 budget reserve fund of the State of Hawaii the sum of \$
7 or so much thereof as may be necessary for fiscal year 2011-2012
8 to provide funding for grants pursuant to chapter 42F, Hawaii
9 Revised Statutes, to The Children's Alliance of Hawaii, Inc., to
10 provide child sex assault services.

11 The sum appropriated shall be expended by the judiciary for
12 the purposes of this Act.

13 SECTION 48. There is appropriated out of the emergency and
14 budget reserve fund of the State of Hawaii the sum of \$
15 or so much thereof as may be necessary for fiscal year 2011-2012
16 to provide funding for grants pursuant to chapter 42F, Hawaii
17 Revised Statutes, to the Young Men's Christian Association of
18 Honolulu for the operation of the weed and seed program in
19 Kalihi-Palama, Waipahu, and Ewa Beach.

20 The sum appropriated shall be expended by the judiciary for
21 the purposes of this Act.



1 SECTION 49. There is appropriated out of the emergency and
2 budget reserve fund of the State of Hawaii the sum of \$
3 or so much thereof as may be necessary for fiscal year 2011-2012
4 for the office of community services for employment core
5 services.

6 The sum appropriated shall be expended by the department of
7 labor and industrial relations for the purposes of this Act.

8 SECTION 50. There is appropriated out of the emergency and
9 budget reserve fund of the State of Hawaii the sum of \$
10 or so much thereof as may be necessary for fiscal year 2011-2012
11 to provide funding for grants pursuant to chapter 42F, Hawaii
12 Revised Statutes, to the Hawaii Disability Rights Center to
13 provide advocacy service to individuals with developmental
14 disabilities and mental illness.

15 The sum appropriated shall be expended by the department of
16 labor and industrial relations for the purposes of this Act.

17 SECTION 51. There is appropriated out of the emergency and
18 budget reserve fund of the State of Hawaii the sum of \$
19 or so much thereof as may be necessary for fiscal year 2011-2012
20 to provide funding for grants pursuant to chapter 42F, Hawaii
21 Revised Statutes, to the Kapiolani Medical Center for Women and



1 Children for the sex abuse treatment center for statewide sex
2 assault services.

3 The sum appropriated shall be expended by the department of
4 the attorney general for the purposes of this Act.

5 SECTION 52. There is appropriated out of the emergency and
6 budget reserve fund of the State of Hawaii the sum of \$
7 or so much thereof as may be necessary for fiscal year 2011-2012
8 for the Families for R.E.A.L. program.

9 The sum appropriated shall be expended by the department of
10 education for the purposes of this Act.

11 SECTION 53. There is appropriated out of the emergency and
12 budget reserve fund of the State of Hawaii the sum of \$
13 or so much thereof as may be necessary for fiscal year 2011-2012
14 to provide funding for grants pursuant to chapter 42F, Hawaii
15 Revised Statutes, to Read Aloud America, Inc., for the read
16 aloud program.

17 The sum appropriated shall be expended by the department of
18 education for the purposes of this Act.

19 SECTION 54. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$
21 or so much thereof as may be necessary for fiscal year 2011-2012
22 to provide funding for grants pursuant to chapter 42F, Hawaii



1 Revised Statutes, to Read To Me International Foundation for
2 reading programs for children of incarcerated parents.

3 The sum appropriated shall be expended by the department of
4 education for the purposes of this Act.

5 SECTION 55. There is appropriated out of the emergency and
6 budget reserve fund of the State of Hawaii the sum of \$
7 or so much thereof as may be necessary for fiscal year 2011-2012
8 to provide funding for grants pursuant to chapter 42F, Hawaii
9 Revised Statutes, to Hawaii Primary Care Association for health
10 care services for uninsured persons.

11 The sum appropriated shall be expended by the department of
12 human services for the purposes of this Act.
