
SENATE CONCURRENT RESOLUTION

SUPPORTING THE COMMUNITY SERVICES BLOCK GRANT PROGRAM AND
STRONGLY OPPOSING BUDGET CUTS PROPOSED BY THE PRESIDENT OF
THE UNITED STATES AND MEMBERS OF THE UNITED STATES
CONGRESS.

1 WHEREAS, the federal Community Services Block Grant program
2 can be traced back to President Lyndon Johnson's "Great Society"
3 programs to eliminate poverty and racial injustice; and
4

5 WHEREAS, the Community Services Block Grant program serves
6 the nation's most vulnerable citizens and has a proven history
7 of allowing low-income individuals to achieve economic security
8 and participate more fully in society; and
9

10 WHEREAS, community action agencies have become a permanent
11 institution in communities throughout the nation; and
12

13 WHEREAS, the Community Services Block Grant program allows
14 state and territory administrators to tailor anti-poverty
15 efforts to address specific problems and capitalize on unique
16 resources in their states; and
17

18 WHEREAS, over one thousand community-based organizations
19 are networked throughout the United States, mobilizing local
20 leaders and institutions to address issues specific to their
21 communities; and
22

23 WHEREAS, the Community Services Block Grant program is the
24 only federal program exclusively focused on reducing poverty;
25 and

27 WHEREAS, the Community Services Block Grant program has
28 helped over twenty million individuals, nearly five million
29 children, over two million elderly, nearly two million
30 individuals with disabilities, and almost four million
31 individuals with no form of health insurance; and

2 WHEREAS, Hawaii has four community action agencies that
3 employ over eight hundred individuals; and
4

5 WHEREAS, Hawaii-based community action programs serve
6 63,776 individuals in 38,817 low-income families, 8,338
7 children, 11,007 individuals with disabilities, and 3,776
8 individuals without health insurance; and
9

10 WHEREAS, federal funding for Hawaii community action
11 agencies helps to generate nearly \$47,000,000 in local funds,
12 translating to \$10.92 in local funds for every Community
13 Services Block Grant dollar invested in the State; and
14

15 WHEREAS, Hawaii-based community action agencies exclusively
16 serve families at or below the federal poverty level; and
17

18 WHEREAS, the nation's current financial crisis will force
19 more families to seek out services that community action
20 agencies provide; and
21

22 WHEREAS, recently, the President of the United States and
23 members of the United States Congress have proposed cutting the
24 budget of the Community Services Block Grant program by fifty
25 percent; and

27 WHEREAS, the proposed cuts to the Community Services Block
28 Grant program will severely impact the ability of community
29 action agencies to properly serve the nation's most vulnerable
30 populations at a time when services are severely needed; now,
31 therefore,

33 BE IT RESOLVED by the Senate of the Twenty-sixth
34 Legislature of the State of Hawaii, Regular Session of 2011, the
35 House of Representatives concurring, that the Legislature
36 support the Community Services Block Grant program and the many
37 positive impacts it has on Hawaii, and strongly oppose the
38 budget cuts proposed by the President of the United States and
39 members of the United States Congress; and

41 BE IT FURTHER RESOLVED that certified copies of this
42 Concurrent Resolution be transmitted to the President of the
43 United States; Majority Leader of the United States Senate;
