Your Committees on International Affairs and Agriculture, to which was referred H.C.R. No. 298 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THAT THE ASIA-PACIFIC ECONOMIC COOPERATION (APEC) HOST COMMITTEE SELECT PRODUCTS UNIQUE TO HAWAII THAT SHOWCASE HAWAII'S EXCELLENCE IN AGRICULTURE,"

beg leave to report as follows:

The purpose of this concurrent resolution is to urge the Asia-Pacific Economic Cooperation (APEC) to promote, showcase, and offer Hawaii's finest confections filled with locally grown products to the dignitaries of the APEC throughout its conference.

The Department of Agriculture (DOA); the Representative of the 27th District; Malie Kai Chocolates, Inc.; Padovani's Chocolates; Manoa Chocolate; and Special Events Hawaii testified in support of this measure.

Your Committees have amended this measure by:

- (1) Broadening the scope of this measure to include all locally grown agricultural products, including tropical flowers and foliage, vegetables, and fruits and value-added products, rather than specifically cacao;
- (2) Requesting DOA to hold a tasting event featuring locally grown products during the APEC conference; and


