
A BILL FOR AN ACT

RELATING TO CONTINUING EDUCATION FOR VETERINARIANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the profession of
2 veterinary medicine has changed significantly within the last
3 ten years. Veterinary medicine is the only profession that
4 routinely operates at the intersection of human and animal
5 health. Veterinarians are challenged with the continuous
6 development of new drugs; new drug therapies; new treatment and
7 modalities for animals, including the use of herbs and
8 alternative drugs; and emerging diseases that affect both
9 animals and humans, such as avian flu. Consumers depend on
10 veterinarians to be fully informed and competent about the
11 proper use of drugs and treatment for their animals. Currently,
12 forty-seven states require continuing education for
13 veterinarians.

14 The purpose of this Act is to require veterinarians in the
15 State of Hawaii to complete a minimum of twenty credit hours of
16 continuing education courses during each licensing biennium.



1 SECTION 2. Section 471-1, Hawaii Revised Statutes, is
2 amended by adding two new definitions to be appropriately
3 inserted and to read as follows:

4 "Continuing education courses" means courses approved by
5 the board of veterinary examiners, Hawaii Veterinary Medical
6 Association, American Association of Veterinary State Boards'
7 Registry, or other board-approved organizations to meet the
8 requirements of this chapter.

9 "Credit hour" means, except as otherwise provided, the
10 value assigned to fifty minutes of instruction."

11 SECTION 3. Section 471-9, Hawaii Revised Statutes, is
12 amended to read as follows:

13 **"§471-9 Licenses.** (a) Except as otherwise provided in
14 this [~~section,~~] chapter, the board of veterinary examiners shall
15 issue a license [~~upon payment of a license fee~~] to engage in the
16 practice of veterinary medicine to all persons meeting the
17 requirements of this chapter[~~-~~] upon payment of a license fee.

18 (b) All licenses issued by the board shall expire on June
19 30 of each even-numbered year next following the date of
20 issuance. Failure to renew the license on or before June 30 of
21 each even-numbered year shall automatically constitute a
22 forfeiture of the license; provided that the license shall be



1 restored upon written application therefor, if the renewal fee,
2 any penalty fees, and documentation of the completion of
3 continuing education credits, as applicable, are submitted by
4 the licensee to the board.

5 ~~[(c) Every veterinarian shall pay a biennial renewal fee in~~
6 ~~each even numbered year. The payment of the renewal fee shall~~
7 ~~entitle the veterinarian to renewal of the license.~~

8 ~~(d) Any holder of an expired license may be reinstated as~~
9 ~~a veterinarian upon payment of the renewal fee and a penalty~~
10 ~~fee.~~

11 ~~(e) Notwithstanding any other provision, no license shall~~
12 ~~expire while the holder thereof is serving on active duty in the~~
13 ~~armed forces of the United States during any emergency declared~~
14 ~~by the President or Congress and six months after the~~
15 ~~termination thereof.]~~

16 (c) Prior to the June 30, 2016, deadline for license
17 renewal, and prior to every license renewal thereafter, a
18 licensee shall:

19 (1) Pay all required fees; and

20 (2) Complete at least twenty credit hours of continuing
21 education within the two-year period preceding the
22 renewal date.



1 (d) A licensee who has graduated from an accredited
2 veterinary school within one year of the licensee's first
3 license renewal shall not be subject to the continuing education
4 requirement for the first license renewal.

5 (e) Each licensee shall be responsible for maintaining the
6 licensee's continuing education records. At the time of
7 renewal, each licensee shall certify under oath that the
8 licensee has complied with the continuing education requirement
9 of this section. The board may require a licensee to submit, in
10 addition to the certification, evidence satisfactory to the
11 board that demonstrates compliance with the continuing education
12 requirement of this section.

13 (f) The board may conduct random audits of licensees to
14 determine compliance with the continuing education requirement.
15 The board shall provide written notice of an audit to a licensee
16 randomly selected for audit. Within sixty days of notification,
17 the licensee shall provide the board with documentation
18 verifying compliance with the continuing education requirement
19 established by this section.

20 (g) Notwithstanding any other provision, no license shall
21 expire while the licensee is serving on active duty in the armed
22 forces of the United States during any emergency declared by the



1 President or Congress and six months after the termination
2 thereof."

3 SECTION 4. Section 471-10, Hawaii Revised Statutes, is
4 amended by amending subsection (b) to read as follows:

5 "(b) In addition to any other actions authorized by law,
6 the board may revoke or suspend the license of any veterinarian,
7 [~~or~~] fine [~~the~~] a licensee, or both, for any cause authorized by
8 law, including but not limited to the following:

- 9 (1) Professional misconduct, gross negligence, or manifest
10 incapacity;
- 11 (2) Violation of this chapter or the rules adopted
12 pursuant thereto or any other law which applies to the
13 licensee as a practicing veterinarian;
- 14 (3) Making any false representations or promises through
15 advertising or otherwise;
- 16 (4) Habitual intemperance in the use of alcoholic
17 beverages or addiction to the use of narcotic or
18 dangerous substances;
- 19 (5) Mental incompetence;
- 20 (6) Any fraudulent, dishonest, or deceitful act in
21 connection with the practice of veterinary medicine;



- 1 (7) Making a false statement [~~in~~] on any document
2 submitted or required to be filed by this chapter[+],
3 including a false certification of compliance with the
4 continuing education requirement;
- 5 (8) Revocation, suspension, or other disciplinary action
6 by another state of a license or certificate for
7 reasons as provided in this section;
- 8 (9) Conviction of or plea of nolo contendere to a penal
9 offense substantially related to the qualifications,
10 functions, or duties of a veterinarian,
11 notwithstanding any statutory provision to the
12 contrary;
- 13 (10) Violation of chapter 329, the uniform controlled
14 substances act, or any rule adopted pursuant thereto;
- 15 (11) Failure to report any disciplinary action taken
16 against [~~a~~] the licensee in another jurisdiction
17 within thirty days after the disciplinary action
18 becomes final; or
- 19 (12) Conduct or practice contrary to the recognized
20 principles of medical ethics of the veterinary
21 profession as adopted by the Hawaii Veterinary Medical



1 Association and the American Veterinary Medical
2 Association."

3 SECTION 5. The board of veterinary medicine shall provide
4 written notification of the contents of this Act to all persons
5 licensed under chapter 471, Hawaii Revised Statutes, within
6 ninety days of the effective date of this Act.

7 SECTION 6. Statutory material to be repealed is bracketed
8 and stricken. New statutory material is underscored.

9 SECTION 7. This Act shall take effect upon its approval,
10 and the continuing education requirements established by this
11 Act shall commence with the licensing biennium for which the
12 renewal deadline is June 30, 2016.
