MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

3 sources of funding indicated below to the department of budget

5 (BUF 101), the following sums or so much thereof as may be
6 necessary to fund for fiscal year 2012-2013 all collective
7 bargaining cost items in the agreement negotiated with the
8 exclusive bargaining representative of collective bargaining
9 unit (9):

2 special, or other funds shall be paid wholly or proportionately,
3 as the case may be, from the respective funds.

4 SECTION 18. The cost adjustments provided in this Act for
5 any officer or employee whose compensation is paid, in whole or
6 in part, from federal, special, or other funds shall be paid
7 wholly or proportionately, as the case may be, from the
8 respective funds.

9 SECTION 19. Funds appropriated or authorized by this Act
10 that are not expended or encumbered by the end of the fiscal
11 year for which the appropriation or authorization is made, shall
12 lapse as of those dates.

13 SECTION 20. This Act shall take effect on July 1, 2012.
