# SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS AND THE NATIONAL ASSOCIATION OF SOCIAL WORKERS, HAWAII CHAPTER, TO DEVELOP CONTINUING EDUCATION REQUIREMENTS FOR LICENSED SOCIAL WORKERS.

1           WHEREAS, the profession of social work provides critically  
2 needed services in prevention, intervention, and treatment to a  
3 broad spectrum of clients; and

4  
5           WHEREAS, it is vitally important that social workers  
6 provide the best possible service to their clients; and

7  
8           WHEREAS, continuing education is essential to help social  
9 workers maintain their professional competency and keep abreast  
10 of the latest developments in their profession; and

11  
12           WHEREAS, Hawaii is one of only three states that do not  
13 require continuing education credits as part of their licensing  
14 law for social workers; and

15  
16           WHEREAS, the National Association of Social Workers is a  
17 membership organization that represents approximately 145,000  
18 social workers across the nation, and the Hawaii chapter  
19 represents about 900 social workers across the state; and

20  
21           WHEREAS, the Department of Commerce and Consumer Affairs is  
22 charged with protecting consumers through its regulatory and  
23 licensing responsibilities; and

24  
25           WHEREAS, the National Association of Social Workers, Hawaii  
26 Chapter, and Department of Commerce and Consumer Affairs are  
27 currently working together on specific provisions to be included  
28 in a bill to establish continuing education requirements for  
29 licensed social workers; and



1 WHEREAS, the National Association of Social Workers, Hawaii  
2 Chapter, and Department of Commerce and Consumer Affairs have  
3 also identified issues relevant to the requirement for  
4 continuing education for licensed social workers, such as:

- 6 (1) Ensuring that such requirements do not impose an undue  
7 burden on social work in rural areas of Hawaii;
  - 8
  - 9 (2) Using an established, widely recognized non-  
10 governmental entity to approve continuing education  
11 credits; and

  - 13 (3) Ensuring that the program to implement and monitor  
14 continuing education credits for licensed social  
15 workers is cost-neutral to the State; and
  - 16

17 WHEREAS, there are currently opportunities offered by  
18 approved providers for continuing education statewide, including  
19 in rural areas, such as through in-person courses, webinars, and  
20 teleconferences; and

22 WHEREAS, continuing education opportunities should be made  
23 available both to members and non-members of the National  
24 Association of Social Workers, Hawaii Chapter; and

25

26 WHEREAS, the joint effort of the Department of Commerce and  
27 Consumer Affairs and National Association of Social Workers,  
28 Hawaii Chapter, is critical in increasing and maintaining the  
29 professional competence of licensed social workers in Hawaii  
30 through a continuing education program; now, therefore,

32 BE IT RESOLVED by the Senate of the Twenty-sixth  
33 Legislature of the State of Hawaii, Regular Session of 2012, the  
34 House of Representatives concurring, that the Department of  
35 Commerce and Consumer Affairs and National Association of Social  
36 Workers, Hawaii Chapter, are urged to continue collaborating on  
37 the issue of developing, including implementing and monitoring,  
38 continuing education requirements for all licensed social  
39 workers in Hawaii; and

41 BE IT FURTHER RESOLVED that at least twenty days prior to  
42 the Regular Session of 2013, the Department of Commerce and  
43 Consumer Affairs and the National Association of Social Workers,  
44 Hawaii Chapter, are requested to submit to the Legislature a

1 proposed draft for a bill to establish, implement, and monitor  
2 continuing education requirements for all licensed social  
3 workers in Hawaii; and
