The purpose and intent of this measure is to support efforts  
of non-governmental organizations that assist in finding  
opportunities and solutions to address homelessness in Hawaii.

Your Committee received testimony in support of this measure  
from Hawaii Youth Services Network and United Self Help.

Your Committee finds homelessness is a multi-faceted issue  
that requires a holistic approach to addressing and eliminating  
homelessness in Hawaii. Many non-governmental organizations  
provide street outreach, emergency shelter, and transitional  
living services to individuals and families who are homeless.  
This measure expresses the Legislature's support of the efforts of  
these non-governmental organizations as they find opportunities  
and solutions to address homelessness in the State.

As affirmed by the record of votes of the members of your  
Committee on Human Services that is attached to this report, your  
Committee concurs with the intent and purpose of S.C.R. No. 130  
and recommends its adoption.
