# HOUSE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT,  
COVERING A PORTION OF STATE SUBMERGED LANDS AT MAHINAHINA,  
LAHAINA, MAUI, FOR RUBBLE ROCK REVETMENT PURPOSES.

1           WHEREAS, the Association of Apartment Owners of Lokelani  
2 owns the property located at 3833 Lower Honoapiilani Road,  
3 Mahinahina, Lahaina, Maui, further identified by tax map key (2)  
4 4-3-006:016; and

5  
6           WHEREAS, a concrete and rubble rock revetment encumbers an  
7 area of 5,597 square feet of state submerged lands identified by  
8 tax map key (2) 4-3-006:065; and

9  
10          WHEREAS, the Office of Conservation and Coastal Lands of  
11 the Department of Land and Natural Resources determined that the  
12 rubble rock revetment was legally constructed in 1975 to prevent  
13 erosion; and

14  
15          WHEREAS, on February 19, 1975, under agenda item F-7, the  
16 Board of Land and Natural Resources approved the issuance of a  
17 month-to-month Revocable Permit No. S-5117 to the Association of  
18 Apartment Owners of Lokelani for the rubble rock revetment; and

19  
20          WHEREAS, a request was made to cancel Revocable Permit No.  
21 S-5117, to allow for the issuance of a more appropriate non-  
22 exclusive term easement for rubble rock revetment purposes; and

23  
24          WHEREAS, on October 14, 2010, under agenda item D-16, the  
25 Board of Land and Natural Resources approved the cancellation of  
26 Revocable Permit No. S-5117 and issuance of a fifty-five year  
27 term, non-exclusive easement to the Association of Apartment  
28 Owners of Lokelani; and

30          WHEREAS, section 171-53, Hawaii Revised Statutes, requires  
31 the prior approval of the Governor and prior authorization of


1 the Legislature by concurrent resolution to lease state  
2 submerged lands; now, therefore,

3  
4 BE IT RESOLVED by the House of Representatives of the  
5 Twenty-sixth Legislature of the State of Hawaii, Regular Session  
6 of 2012, the Senate concurring, that the Board of Land and  
7 Natural Resources is hereby authorized to issue a fifty-five  
8 year term, non-exclusive easement covering a portion of state  
9 submerged and reclaimed (filled) lands identified as tax map  
10 key: (2) 4-3-003:065 at Lahaina, Maui, compromising 5,597 square  
11 feet, for maintenance, repair, replacement, and removal of an  
12 existing rubble rock revetment over, under, and across state-  
13 owned lands; and

15 BE IT FURTHER RESOLVED that a certified copy of this  
16 Concurrent Resolution be transmitted to the Chairperson of the  
17 Board of Land and Natural Resources.
