
HOUSE CONCURRENT RESOLUTION

REQUESTING A STUDY ON THE REGIONAL TRAFFIC IMPACTS OF PROPOSED DEVELOPMENTS AND INCREASING TOURISM IN THE NORTH SHORE AND KOOLAULOA DISTRICTS.

1 WHEREAS, the North Shore and Koolauloa districts of Oahu
2 are rural, sparsely populated communities that are accessed via
3 the narrow, two lane Kamehameha Highway; and
4

5 WHEREAS, traffic congestion along this regional highway has
6 become a major problem for residents, visitors, businesses and
7 emergency services who get trapped in its gridlock; and
8

9 WHEREAS, expansion of the Turtle Bay Resort could add
10 several hundred vehicles per hour to the already congested
11 roadway; and
12

13 WHEREAS, the proposed Malaekahana residential development
14 could also add hundreds of additional vehicles to Kamehameha
15 Highway; and
16

17 WHEREAS, development in Central Oahu has contributed to the
18 traffic congestion on weekends and holidays, and the proposed
19 Koa Ridge development could exacerbate existing congestion; and
20

21 WHEREAS, more than fifty percent of visitors to Oahu visit
22 the North Shore, thousands of them traveling daily in rental
23 cars which add to traffic congestion; and

25 WHEREAS, various in-fill developments, such as Kahuku
26 Haleiwa, Waialua and smaller projects would add even more demand
27 to highway capacity; and

1 WHEREAS, there is very little capacity along Kamehameha
 2 Highway in the North Shore and Koolauloa Districts to absorb
 3 additional traffic demand; and
 4

5 WHEREAS, individual development projects are required only
 6 to study background conditions and the impacts their own
 7 projects will generate, yet total regional impacts of all
 8 potential developments and increasing tourism are not
 9 comprehensively studied and considered; now, therefore,
 10

11 BE IT RESOLVED by the House of Representatives of the
 12 Twenty-sixth Legislature of the State of Hawaii, Regular Session
 13 of 2012, the Senate concurring, that the Hawaii Department of
 14 Transportation study the cumulative traffic impacts of all
 15 proposed and likely developments on Kamehameha Highway in the
 16 North Shore and Koolauloa Districts; and
 17

18 BE IT FURTHER RESOLVED that the traffic impacts studied
 19 shall include all related traffic factors such as background
 20 levels, large developments, rental cars and tour buses, in-fill
 21 residential developments, and all other related factors; and
 22

23 BE IT FURTHER RESOLVED that the study analyze the
 24 cumulative traffic impacts with regard to highway capacity, such
 25 as vehicles per hour ratios, levels of service and other
 26 relevant statistical data;
 27

28 BE IT FURTHER RESOLVED that the Department of
 29 Transportation submit a report, including any recommendations,
 30 to the Legislature no later than twenty days prior to the
 31 convening of the Regular Session of 2013; and
 32

33 BE IT FURTHER RESOLVED that a certified copy of this
 34 Concurrent Resolution be transmitted to the Director of the
 35 Department of Transportation.
