
HOUSE CONCURRENT RESOLUTION

SUPPORTING THE ESTABLISHMENT OF A VETERANS COURT WITHIN THE
HAWAII STATE CIRCUIT COURT.

1 WHEREAS, the Hawaii prison system is severely overcrowded,
2 and further alternatives to incarceration are needed; and
3

4 WHEREAS, judges in Hawaii have reported an increase in
5 criminal cases that involve veterans as defendants; and
6

7 WHEREAS, a veteran means a person who served on active duty
8 in the armed forces of the United States, a reserve component,
9 or the national guard and was federally activated and honorably
10 discharged; and
11

12 WHEREAS, research confirms that a significant number of
13 veterans return from combat with a combat-related mental health
14 condition such as post traumatic stress disorder, traumatic
15 brain injury, sexual trauma, substance abuse, or other mental
16 and emotional health conditions; and
17

18 WHEREAS, veterans courts in other states across the country
19 have succeeded in turning around the lives of many veterans
20 before they enter the criminal justice system; and
21

22 WHEREAS, veterans courts can assist participating veterans
23 with rehabilitation, medical care, mental health, substance
24 abuse, housing, employment services, and counseling assistance;

27 WHEREAS, a veterans court will serve the dual purposes of
28 addressing the special needs of our State's veterans and
29 reducing crowding in the State's prisons and jails; and

1 WHEREAS, Hawaii is the only State in the nation with the
 2 presence of all five branches of the military and has a high
 3 number of returning combat veterans; and
 4

5 WHEREAS, Hawaii is a unique venue for a veterans court to
 6 succeed, given the State's military population; now, therefore,
 7

8 BE IT RESOLVED by the House of Representatives of the
 9 Twenty-sixth Legislature of the State of Hawaii, Regular Session
 10 of 2012, the Senate concurring, that this body supports the
 11 establishment of a veterans court within the Hawaii state
 12 circuit court; and
 13

14 BE IT FURTHER RESOLVED that certified copies of this
 15 Concurrent Resolution be transmitted to the Chief Justice of the
 16 Hawaii Supreme Court, Administrative Director of the Courts, the
 17 Director of Public Safety, and the Director of the Office of
 18 Veterans' Services.
