14 recognize SHARON E. HAR as a Majority Whip who was duly elected

18 the Vice Chair of the Water, Land, & Ocean Resources Committee
19 and a member of the Finance Committee, the Energy &
20 Environmental Protection Committee, and the Housing Committee;

23 BE IT FURTHER RESOLVED that TOM OKAMURA, who has been duly
24 appointed and seated as a member of the House of Representatives
25 from the Thirty-third Representative District to fill the
26 vacancy created by the resignation of former Representative
27 Blake K. Oshiro, shall be a member of the Labor & Public
28 Employment Committee, the Public Safety & Military Affairs
29 Committee, the Transportation Committee, the Education
30 Committee, and the Higher Education Committee; and

 12 by the House of Representatives of the Twenty-sixth Legislature
 13 of the State of Hawaii, Regular Session of 2011, shall remain in
 14 full force and effect, it being understood that the name of
 15 BLAKE K. OSHIRO, wherever the name appears in the aforementioned
 16 H.R. No. 6 adopted by the House of Representatives of the
 17 Twenty-sixth Legislature of the State of Hawaii, Regular Session
 18 of 2011, is deleted.
