
SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES, DEPARTMENT OF HEALTH, AND OFFICE OF PLANNING TO STREAMLINE THE PERMITTING PROCESS FOR THE RESTORATION OF HAWAIIAN FISHPONDS.

1 WHEREAS, repair of many Hawaiian fishponds may require
2 permits from the Department of Land and Natural Resources,
3 Department of Health, Office of Planning, and federal and county
4 governments; and

6 WHEREAS, the process in obtaining a permit for the
7 restoration of Hawaiian fishponds is time consuming,
8 complicated, and confusing and varies depending upon the
9 circumstances of party applying for the permit; and

11 WHEREAS, the existing regulations and permit requirements
12 preclude community organizations and Native Hawaiian
13 aquaculturalists from repairing and maintaining Hawaiian
14 fishponds; and

16 WHEREAS, the State has the ability to streamline the permit
17 process and promote interagency cooperation to facilitate
18 restoration and leasing of fishponds to cultural and familial
19 descendants; and

21 WHEREAS, the State has not led a comprehensive initiative
22 to streamline the permit process for restoration of Hawaiian
23 fishponds in over thirty years; and

25 WHEREAS, the restoration and reuse of *loko i'a* provide an
26 opportunity to increase supplies of certain fish which will make
27 Hawaii more food-secure and increase sustainable economic
28 development opportunities for rural communities; now, therefore,

30 BE IT RESOLVED by the Senate of the Twenty-sixth
31 Legislature of the State of Hawaii, Regular Session of 2012, the



1 House of Representatives concurring, that the Department of Land
2 and Natural Resources, Department of Health, and Office of
3 Planning are urged to streamline the permitting process for the
4 restoration of Hawaiian fishponds; and

6 BE IT FURTHER RESOLVED that the Department of Land and
7 Natural Resources, Department of Health, and Office of Planning,
8 in collaboration with community organizations and Native
9 Hawaiian aquaculturalists, consider the following to facilitate
10 restoration of Hawaiian fishponds:

- 12 (1) One master conservation district use application
- 13 process that applies to all Hawaiian fishponds;
- 14
- 15 (2) A coastal zone management program consistency
- 16 statement for Hawaiian fishponds;
- 17
- 18 (3) Water quality certification for Hawaiian fishponds;
- 19
- 20 (4) A national pollution discharge elimination system
- 21 general permit for Hawaiian fishponds; and
- 22
- 23 (5) Administrative rules to be applied consistently
- 24 throughout the State; and
- 25

26 BE IT FURTHER RESOLVED that the Department of Land and
27 Natural Resources, Department of Health, and Office of Planning
28 are requested to submit their recommendations and draft
29 legislation for a streamlined permit process for the restoration
30 of Hawaiian fishponds to the Legislature no later than twenty
31 days prior to the convening of the Regular Session of 2013; and

33 BE IT FURTHER RESOLVED that certified copies of this
34 Concurrent Resolution be transmitted to the Governor,
35 Chairperson of the Board of Land and Natural Resources, Director
36 of Health, and Director of the Office of Planning.
