SENATE RESOLUTION

REQUESTING THE PUBLIC LAND DEVELOPMENT CORPORATION TO SUBMIT A SEMI-ANNUAL REPORT TO THE LEGISLATURE AND THE BOARD OF DIRECTORS OF THE CORPORATION TO SUBMIT AN ANNUAL EVALUATION OF THE EXECUTIVE DIRECTOR OF THE CORPORATION TO THE LEGISLATURE.

1 WHEREAS, the Public Land Development Corporation
2 ("Corporation") is a public body corporate and politic and an
3 instrumentality and agency of the State; and
4

5 WHEREAS, the Corporation coordinates and administers
6 programs to make optimal use of public land, while ensuring that
7 the public land is maintained for the people of Hawaii; and
8

9 WHEREAS, the Corporation identifies public lands that are
10 suitable for development, provides marketing analyses to
11 determine the best revenue-generating programs for public lands
12 identified, enters into public-private agreements to
13 appropriately develop the public lands identified, and provides
14 leadership for the development, financing, improvement, or
15 enhancement of the selected development opportunities; and

17 WHEREAS, the Corporation is governed by its Board of
18 Directors, consisting of five voting members, and an appointed
19 Executive Director; and

21 WHEREAS, existing statute requires the Corporation to
22 report its activities to the Legislature no later than twenty
23 days prior to the convening of each regular session; and

25 WHEREAS, the Corporation was recently established by Act
26 55, Session Laws of Hawaii 2011, and is charged with overseeing
27 current highly controversial and sensitive issues facing the
28 State; and

30 WHEREAS, due to the importance of the issues the
31 Corporation handles, additional reporting is necessary to ensure
32 the proper oversight of its duties; now, therefore,

1 BE IT RESOLVED by the Senate of the Twenty-sixth
2 Legislature of the State of Hawaii, Regular Session of 2012,
3 that the Public Land Development Corporation is requested to
4 submit a semi-annual report to the Legislature no later than one
5 hundred eighty days after the submission of the annual report
6 submitted pursuant to section 171C-20, Hawaii Revised Statutes;
7 and

9 BE IT FURTHER RESOLVED that the Board of Directors of the
10 Public Land Development Corporation is requested to submit an
11 annual evaluation of the Executive Director of the Corporation
12 to the Legislature no later than twenty days prior to the
13 convening of each regular session; and

15 BE IT FURTHER RESOLVED that certified copies of this
16 Resolution be transmitted to the members of the Board of
17 Directors of the Public Land Development Corporation and the
18 Executive Director of the Public Land Development Corporation.
