Sirs:

Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2833, S.D. 1, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO EMPLOYMENT EXEMPTION FOR DOMESTIC SERVICES FOR PERSONS WITH DEVELOPMENTAL AND INTELLECTUAL DISABILITIES,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to exempt domestic in-home and community-based services provided through state-funded medical assistance to Medicaid-ineligible individuals with developmental and intellectual disabilities from the Hawaii Prepaid Health Care Act and laws relating to unemployment insurance, workers' compensation, and temporary disability insurance.

Your Committee on Conference finds that this measure will allow individuals with developmental or intellectual disabilities greater



access to needed services and increased flexibility in obtaining such services.


Your Committee on Conference has amended this measure by changing the effective date to upon approval.




