Jan. 20 th (Fri)	3 rd	Last day to introduce all packages of bills except for the administration's (State Executive Branch).
Jan. 23 rd (Mon)	4 th	State-of-the-State Address. Last day to introduce the administration's package of bills (State Executive Branch).
Jan. 24 th (Tue)		One-day recess
Jan. 25 th (Wed)	5 th	Last day for bill introductions.
Jan. 26 th (Thur)		One-day recess.
Jan. 31 st (Tue)	8 th	Last day for organizations to submit grant and subsidy requests to the Legislature.
