A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that homelessness
3	continues to be one of the State's most significant and
4	challenging social problems. The legislature further finds that
5	according to a recent report, fourteen thousand two hundred
6	homeless individuals were served through shelter and outreach
7	programs in fiscal year 2011. Of these individuals, nine
8	thousand seven hundred eighty-one resided in the city and county
9	of Honolulu. The legislature also finds that homeless service
10	providers estimate that six thousand homeless people in the
11	State need shelter each night.
12	The legislature additionally finds that homelessness is a
13	complex issue that requires continuous resources and coordinated
14	efforts at all levels. The legislature also finds that homeless
15	persons face a myriad of issues, including mental illness,
16	substance abuse, loss of employment and income, and a lack of
17	affordable housing. Appropriate funding for programs and
18	services tailored to address these issues is essential.

1	The purpose of this part is to better assist individuals
2	facing or experiencing homelessness by funding various homeless
3	and housing programs.
4	SECTION 2. There is appropriated out of the general
5	revenues of the State of Hawaii the sum of \$300,000 or so much
6	thereof as may be necessary for fiscal year 2013-2014 for
7	substance abuse treatment and mental health support services for
8	individuals who are homeless or at risk of becoming homeless.
9	The sums appropriated shall be expended by the department
10	of health for the purposes of this part.
11	SECTION 3. There is appropriated out of the general
12	revenues of the State of Hawaii the sum of \$200,000 or so much
13	thereof as may be necessary for fiscal year 2013-2014 for clean
14	and sober housing support services to be administered by the
15	alcohol and drug abuse division of the department of health.
16	The sums appropriated shall be expended by the department
17	of health for the purposes of this part.
18	PART II
19	SECTION 4. There is appropriated out of the general
20	revenues of the State of Hawaii the sum of \$1,000,000 or so much

thereof as may be necessary for fiscal year 2013-2014 for a

rental assistance program, also known as a shallow subsidy

- 2 are ready to rent permanent housing to obtain and maintain
- 3 permanent housing; provided that:
- 4 (1) The maximum subsidy shall be \$300 per month; provided
 5 that in order to qualify for the subsidy, a household

 7 adjusted gross income for rent; and
- 8 (2) A household's adjusted gross income shall be
 9 calculated in the same manner as calculated by the
 10 Hawaii public housing authority to qualify for public housing under the authority's control.

The sums appropriated for program and administrative costs associated with establishing and operating the shallow subsidy program shall be expended by the department of human services through a contract issued pursuant to chapter 103F, Hawaii Revised Statutes, and sums appropriated for staff within the homeless programs office to administer the program shall be expended by the department of human services for the purposes of this part.

21 SECTION 5. The legislature finds that housing first

22 programs are a collaborative effort between the department of

1	human ser	vices and the United States Department of Housing and			
2	Urban Development that provides housing and support services for				
3	chronical	ly homeless individuals, including those who have an			
4	addiction	or mental illness, or both. The principles of housing			
5	first pro	grams include:			
6	(1)	Moving chronically homeless individuals into housing			
7		directly from streets and the shelters without a			
8		precondition of accepting or complying with treatment;			
9	(2)	Providing robust support services for program			
10		participants that are predicated on assertive			
11		engagement rather than coercion;			
12	(3)	Granting chronically homeless individuals priority as			
13		program participants in housing first programs;			
14	(4)	Embracing a harm-reduction approach to addictions			
15		rather than mandating abstinence while supporting			
16		program participant commitments to recovery; and			
17	(5)	Providing program participants with leases and tenant			
18		protections as provided by law.			
19	The	housing first programs in the State closely resemble			
20	the requi	rements of the United States Housing and Urban			
21	Developme	nt shelter plus care program and the Veterans			

Administration veteran's assisted supportive housing voucher

- 1 program for homeless veterans. In its December 2011 report to
- 2 the legislature pursuant to section 346-378, Hawaii Revised
- 3 Statutes, the department of human services reported that the
- 4 State has six hundred fifty-eight permanent housing placements
- 5 plus support services through the shelter plus care and
- 6 veteran's assisted supportive housing voucher programs.
- 7 The purpose of this part is to appropriate funds to the
- 8 department of human services to support the State's housing
- 9 first programs in assisting Hawaii's chronically homeless who
- 10 are often the most vulnerable, most visible, and most difficult
- 11 to serve.
- 12 SECTION 6. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$750,000 or so much
- 14 thereof as may be necessary for fiscal year 2013-2014 to be
- 15 deposited to the credit of the housing first special fund
- 16 established under section 346-377, Hawaii Revised Statutes, for
- 17 the department of human services to continue to administer
- 18 housing first programs for chronically homeless individuals in
- 19 the State.
- 20 SECTION 7. There is appropriated out of the housing first
- 21 special fund the sum of \$750,000 or so much thereof as may be
- 22 necessary for fiscal year 2013-2014 for the department of human

- 1 services to continue to administer housing first programs for
- 2 chronically homeless individuals in the State.
- 3 The sums appropriated shall be expended by the department
- 4 of human services for the purposes of this part.
- 5 PART IV
- 6 SECTION 8. The legislature finds that the purpose of the
- 7 United States Department of Housing and Urban Development's
- 8 homelessness prevention and rapid re-housing program was to
- 9 provide economically distressed households and individuals with
- 10 financial and other assistance to prevent them from becoming
- 11 homeless and help those who are experiencing homelessness to be
- 12 quickly re-housed and stabilized. The funds under this program
- 13 were intended to target individuals and families who would be
- 14 homeless but for this assistance.
- 15 The department of human services administered the
- 16 homelessness prevention and rapid re-housing program to provide
- 17 homeless prevention and housing assistance to all eligible
- 18 individuals and households who apply through contracted
- 19 organizations. The funds from the program provided for a
- 20 variety of assistance, including short-term or medium-term
- 21 rental assistance and housing relocation, and stabilization

- 1 services, such as mediation, security or utility deposits,
- 2 utility payments, moving cost assistance, and case management.
- 3 The purpose of this part is to appropriate funds to the
- 4 department of human services to once again provide homelessness
- 5 prevention and rapid re-housing assistance to all eligible
- 6 individuals and households.
- 7 SECTION 9. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$150,000 or so much
- 9 thereof as may be necessary for fiscal year 2013-2014 for the
- 10 homelessness prevention and rapid re-housing program.
- 11 The sums appropriated shall be expended by the department
- 12 of human services for the purposes of this part.
- 13 PART V
- 14 SECTION 10. The shelter plus care program of the United
- 15 States Department of Housing and Urban Development provides
- 16 rental assistance in connection with supportive services. The
- 17 program provides a variety of permanent housing choices,
- 18 accompanied by a range of supportive services funded through
- 19 other sources. The program assists hard-to-serve homeless
- 20 individuals with disabilities and their families. These
- 21 individuals primarily include those with serious mental illness,

- 1 chronic problems with alcohol and drugs, and HIV, AIDS, or
- 2 related diseases.
- 3 There are four components to the shelter plus care program:
- 4 single room occupancy component moderate rehabilitation for
- 5 single-room occupancy dwellings; sponsor-based rental assistance
- 6 component; project-based rental assistance component; and
- 7 tenant-based rental assistance component. Under all components,
- 8 supportive services must be available to meet the needs of
- 9 participants. Similar to many other federal programs, the
- 10 shelter plus care program has a match requirement. Applicants
- 11 must match the aggregate amount of shelter plus care rental
- 12 assistance with supportive services. This ensures that
- 13 appropriate and timely services will be available to meet the
- 14 needs of individual participants.
- 15 The purpose of this part is to provide matching funds for
- 16 the shelter plus care program.
- 17 SECTION 11. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$400,000 or so much
- 19 thereof as may be necessary for fiscal year 2013-2014 for
- 20 matching funds for the shelter plus care program of the United
- 21 States Department of Housing and Urban Development.

Ţ	The sums appropriated shall be expended by the department
2	of human services for the purposes of this part.
3	PART VI
4	SECTION 12. The legislature finds that many homeless
5	persons are known to thrive better when they have ready access
6	to familiar support groups or family members. The intent of the
7	return-to-home program is to ensure that those individuals who
8	find themselves homeless in the islands are able to reconnect
9	with support networks ready and able to receive them.
10	The purpose of this part is to establish a three-year
11	return-to-home program for eligible homeless individuals.
12	SECTION 13. (a) The department of human services may
13	coordinate a voluntary homeless assistance pilot program to be
14	known as the return-to-home pilot program to provide eligible
15	homeless individuals with assistance in being reunited with
16	family and relatives in the individual's home state. The
17	department may contract with eligible non-profit organizations,
18	for profit organizations, or foundations to administer the pilot

1	(1)	The individual's	participation	is	completely
2		voluntary;			

- 3 (2) The individual, if on parole, probation, or awaiting a
 4 court hearing or sentencing, has proper clearance from
 5 the court to participate in the pilot program; and
- 6 (3) The individual is indigent and lacks the financial
 7 resources necessary to secure transportation to return
 8 to the individual's home state.
- 9 (c) An individual may participate in the return-to-home 10 pilot program only once and shall sign an agreement to this 11 effect before participating in the pilot program. The agreement 12 shall be kept on file with the pilot program.
- (d) The return-to-home pilot program shall actively seek
 the participation of local airlines, cruise lines, charter
 companies, homeless programs, travel agencies, and the visitor
 industry to coordinate and implement the pilot program.
- (e) The return-to-home pilot program shall assist program
 participants with necessary and proper preparations for travel,
 including obtaining proper identification, accessing public
 transportation to the airport, providing orientation relating to
 airport security, and ensuring sufficient personal hygiene.

- 1 (f) The return-to-home pilot program shall cease to exist
- 2 on December 31, 2016.
- 3 SECTION 14. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$100,000 or so much
- 5 thereof as may be necessary for fiscal year 2013-2014 for
- 6 implementation of the return-to-home pilot program, including
- 7 all program costs and hiring of necessary staff.
- 8 The sum appropriated shall be expended by the department of
- 9 human services for the purposes of this part.
- 10 PART VII
- 11 SECTION 15. The legislature finds that homelessness
- 12 continues to be one of the State's most significant and
- 13 challenging social problems. The number of homeless persons in
- 14 the State, estimated to be approximately six thousand on any
- 15 given day, is indicative of the limited shelter space available.
- 16 The legislature further finds that new and innovative
- 17 solutions are needed to address the homelessness crisis.
- 18 Oregon, for example, has adopted laws that authorize political
- 19 subdivisions to allow religious institutions to offer overnight
- 20 camping space for homeless persons living in vehicles.
- 21 Similarly, Santa Barbara, California, has instituted a program
- 22 that allows private organizations to use county-owned parking



1	lots to provide overnight sleeping space for homeless persons					
2	with vehicles.					
3	The purpose of this part is to establish a homeless					
4	assistance working group to work within each local neighborhood					
5 ,	in each county to identify, plan, and implement housing options					
6	for homeless persons in each local community by December 31,					
7	2013, that reflect shared responsibility for addressing					
8	homelessness in Hawaii.					
9	SECTION 16. (a) There is established within the					
10	department of human services a homeless assistance working					
11	group. The purpose of the working group shall be to:					
12	(1) Work within each local neighborhood in each county to					
13	identify various private and public properties whose					
14	owners are interested in partnering with the local					
15	neighborhood and government to provide land or					
16	structures that can be used to provide temporary homes					
17	for homeless persons, including people who are living					
18	in their motor vehicles;					
19	(2) Coordinate with the State's homeless programs office					
20	and continuum of care providers to match homeless					
21	persons in every community with appropriate care and					

housing;

	(3)	MOIR WICH HOH PIOLIC OLGANIZACIONS, Dasinesses, and
2		government agencies that may be willing to offer their
3		property for homeless persons living in their motor

11	(10)	Representatives of the technology community;
12	(11)	Various federal, state, and county and city
13		representatives, including the chair of the Hawaii
14		interagency council on homelessness and homeless
15		programs office administrator;
16	(12)	Interested federal, state, county, and city elected
17		officials; and
18	(13)	Others interested in supporting homeless assistance.
19	The membe	rs of the working group shall designate a chair from
20	among the	mselves and serve without compensation.
21	(c)	The working group shall convene within thirty days of
22	the effec	tive date of this Act.

- 1 (d) The working group shall submit an interim report of
- 2 its findings and recommendations, including the progress made to
- 3 provide housing and support services, as appropriate, for
- 4 homeless persons and any innovative temporary housing solutions,
- 5 to the legislature no later than one hundred fifty days after
- 6 the effective date of this Act.
- 7 (e) The homeless assistance working group shall dissolve
- 8 on June 30, 2016.
- 9 SECTION 17. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$100,000 or so much
- 11 thereof as may be necessary for fiscal year 2013-2014 for the
- 12 construction and demonstration of innovative temporary housing
- 13 solutions as they relate to the working group's findings and
- 14 recommendations.
- 15 The sum appropriated shall be expended by the department of
- 16 human services for the purposes of this Act.
- 17 PART VIII
- 18 SECTION 18. This Act shall take effect on July 1, 2013;
- 19 provided that part VI shall take effect no later than
- 20 December 31, 2013.

Homelessness; Housing; Return-to-Home Pilot Program; Homeless Assistance Working Group; Appropriation

Description:

Part I: Appropriates funds to the department of health for substance abuse treatment, mental health support services, and clean and sober housing services. Part II: Appropriates funds for a rental assistance program, also known as a shallow subsidy program. Parts III and IV: Appropriates funds to the Hawaii public housing authority to continue to administer housing first programs for chronically homeless individuals and to reestablish the homeless prevention and rapid re-housing program. Part V: Appropriates matching funds for the federal shelter plus care program to provide rental assistance in connection with supportive services. Part VI: Establishes a three-year returnto-home pilot program beginning no later than 12/31/13. Part VII: Establishes homeless assistance working group. (CD1)
