# A BILL FOR AN ACT

RELATING TO GOVERNMENT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that Act 54, Session Laws  
2 of Hawaii 2011, establishes a comprehensive information system  
3 for public lands to be used for the inventory and maintenance of  
4 information relating to the public land trust, also known as  
5 ceded lands, and other state lands. All state and county  
6 agencies are directed to assist the department of land and  
7 natural resources in facilitating the establishment of the  
8 comprehensive information system for public lands.

9           The legislature further finds that the inventory required  
10 to be taken and information to be maintained are important tools  
11 to assist the State to manage its assets.

12           The legislature further finds that insufficient information  
13 on underutilized public facilities exacerbates lost revenues for  
14 the State, so it is important that all state and county agencies  
15 work together to ensure that state facilities are used to their  
16 fullest potential.

17           The purpose of this Act is to require the department of  
18 accounting and general services to expand the scope of the



1 comprehensive information system established pursuant to Act 54,  
2 Session Laws of Hawaii 2011, to inventory and maintain  
3 information about the lands of the public land trust described  
4 in section 5(f) of the Admission Act and article XII, section 4,  
5 of the Hawaii State Constitution to include public buildings,  
6 facilities, and sites thereby creating a comprehensive asset  
7 management system for public lands and facilities.

8 SECTION 2. Act 54, Session Laws of Hawaii 2011, is amended  
9 by adding a new section to read as follows:

10 "SECTION 2A. (a) The department of accounting and general  
11 services shall initiate and coordinate all efforts to establish  
12 a complete and accurate inventory of public buildings,  
13 facilities, and sites on the lands of the public land trust to  
14 which state agencies hold title or over which they maintain  
15 management control.

16 (b) The department of accounting and general services  
17 shall incorporate the inventory of public buildings, facilities,  
18 and sites together with the public land trust inventory and the  
19 public land trust information system to create an integrated,  
20 comprehensive system for asset management of public buildings,  
21 facilities, and sites. All state agencies shall transfer to the  
22 department of accounting and general services all programs and



1 hardware associated with the inventory for purposes of this  
2 subsection.

3 (c) All state and county agencies shall assist the  
4 department of accounting and general services in gathering the  
5 information required by this section, and shall comply with  
6 requests for information or services by the department of  
7 accounting and general services in furtherance of this section.

8 (d) All state agencies shall report to the department of  
9 accounting and general services by January 1, 2014, an inventory  
10 of public buildings, facilities, and sites owned or operated by  
11 the reporting agency. All state agencies shall thereafter  
12 submit to the department of accounting and general services an  
13 updated annual inventory of public buildings, facilities, and  
14 sites owned or operated by the reporting agency.

15 (e) As used in this Act, the term "public buildings,  
16 facilities, and sites" shall have the same meaning as set forth  
17 in section 103-50, Hawaii Revised Statutes."

18 SECTION 3. There is appropriated out of the general  
19 revenues of the State of Hawaii the sum of \$ or so much  
20 thereof as may be necessary for fiscal year 2013-2014 and the  
21 same sum or so much thereof as may be necessary for fiscal year  
22 2014-2015 for the department of accounting and general services



1 to coordinate the inventory of public buildings, facilities, and  
2 sites and for the creation of a comprehensive system for asset  
3 management.

4 The sums appropriated shall be expended by the department  
5 of accounting and general services for the purposes of this Act.

6 SECTION 3. New statutory material is underscored.

7 SECTION 4. This Act shall take effect on July 1, 2050.



**Report Title:**

State Asset Management System; Facilities; DAGS

**Description:**

Requires the department of accounting and general services to establish an inventory of public buildings, facilities, and sites on the lands of the public land trust to which state agencies hold title. Requires state agencies to provide the department of accounting and general services with an inventory of public buildings, facilities, and sites by January 1, 2014, all programs and hardware associated with the inventory, and an updated inventory of buildings and facilities annually. Effective 7/1/2050. (SD2)
