SENATE CONCURRENT RESOLUTION

REQUESTING THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY TO LEASE A PORTION OF LAND COMPRISING THE KALAELOA COMMUNITY DEVELOPMENT DISTRICT TO THE UNITED STATES COAST GUARD FOR A FACILITY TO BE DESIGNATED AS THE COAST GUARD PACIFIC REGIONAL CENTER AT KALAELOA.

1 WHEREAS, the Hawaii Community Development Authority has
2 jurisdiction over the Kalaeloa Community Development District
3 (Kalaeloa) pursuant to section 206E-193, Hawaii Revised
4 Statutes; and

6 WHEREAS, Kalaeloa includes the land formerly occupied by
7 the Barbers Point Naval Air Station and consists of
8 approximately 3,700 acres of land, including waterfront land,
9 bounded by Ewa, Kapolei, and the Campbell Industrial Park; and

11 WHEREAS, the United States Coast Guard District 14 (search
12 and rescue) is currently headquartered in Honolulu in the
13 federal building on Ala Moana Boulevard; and

14
15 WHEREAS, the United States Coast Guard would prefer to be
16 headquartered at Kalaeloa in the interests of proximity to Joint
17 Base Pearl Harbor Hickam and being more centrally located on
18 Oahu; and

20 WHEREAS, Kalaeloa was formerly the location of Barbers
21 Point Naval Air Station, which makes the site an ideal location
22 for the United States Coast Guard District 14 headquarters; and

24 WHEREAS, Kalaeloa presently contains an elementary school,
25 airport, National Guard, Coast Guard air station, Hale 'Ulu
26 Pono shelter, veteran's services, post office, University of
27 Hawaii aerospace center, various Navy facilities, rental
28 housing, commercial entities, public beaches, and recreational
29 areas; however, most of Kalaeloa remains undeveloped; now,

2 BE IT RESOLVED by the Senate of the Twenty-seventh
3 Legislature of the State of Hawaii, Regular Session of 2013, the
4 House of Representatives concurring, that the Hawaii Community
5 Development Authority is requested to lease a portion of the
6 land comprising the Kalaeloa Community Development District to
7 the United States Coast Guard District 14 for a facility to be
8 designated as the Coast Guard Pacific Regional Center at
9 Kalaeloa; and

11 BE IT FURTHER RESOLVED that certified copies of this
12 Concurrent Resolution be transmitted to the Hawaii Community
13 Development Authority and the Commander of the Fourteenth Coast
14 Guard District.
