Your Committee on Ways and Means, to which was referred
S.C.R. No. 103 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE
SUBMERGED LANDS PURSUANT TO SECTION 171-53, HAWAII REVISED
STATUTES, RELATING TO RECLAMATION AND DISPOSITION OF
SUBMERGED OR RECLAIMED PUBLIC LAND,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize,
pursuant to section 171-53, Hawaii Revised Statutes, the issuance
of a fifty-five-year nonexclusive easement to the owners of the
abutting property identified by tax map key: (1) 6-1-003:0024-
0001.

Your Committee finds that the owners of the subject property
requested an easement to resolve the encroachment of the
property's seawall into state submerged lands. On January 11,
2013, under agenda item D-13, the Board of Land and Natural
Resources approved the request for the fifty-five-year easement.
Your Committee further finds that this measure satisfies section
171-53, Hawaii Revised Statutes, which requires legislative
approval by concurrent resolution prior to the leasing of state
submerged lands.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 103
and recommends its adoption.
