Your Committee on Water & Land, to which was referred S.C.R. No. 172, S.D. 2, entitled:

"SENATE CONCURRENT RESOLUTION ENCOURAGING THE COUNTY OF HAWAII TO CONTINUE NEGOTIATIONS WITH THE PRIVATE LESSEE OF STATE LAND TO MUTUALLY CANCEL THE LEASE OR, ALTERNATIVELY, TO OBTAIN A PUBLIC EASEMENT IN FAVOR OF THE COUNTY TO ALLOW THE COUNTY TO PROCEED WITH ITS PLANS FOR THE WAIMEA TRAILS AND GREENWAYS TRAILHEAD AND COUNTY PARK,"
