Your Committee on Ways and Means, to which was referred
S.C.R. No. 199, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION URGING THE BOARD OF REGENTS OF
THE UNIVERSITY OF HAWAII TO ESTABLISH A THREE-YEAR MORATORIUM
ON ANY INCREASES OF RESIDENT TUITION,"

begs leave to report as follows:

The purpose and intent of this measure is to urge the Board
of Regents to establish a three-year moratorium on any increases
in resident tuition for the University of Hawaii, effective
July 1, 2014.

Your Committee received written comments on this measure from
the University of Hawaii System.

Your Committee finds that the tuition and fees at the
University of Hawaii have steadily increased during the past five
years and at a rate much higher than the national average for
other public universities. These substantial tuition increases
may discourage residents from attending the University of Hawaii.
Accordingly, your Committee believes that a moratorium on resident
tuition increases would enable more Hawaii residents to enroll at
the University and make higher education more accessible and
affordable for state residents.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your



Committee concurs with the intent and purpose of S.C.R. No. 199, S.D. 1, and recommends its adoption.
