Your Committee on Ways and Means, to which was referred  
S.C.R. No. 22 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A  
TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE  
SUBMERGED LANDS AT KAALAEA, KOOLAUPOKO, OAHU, FOR THE  
MAINTENANCE AND REPAIR OF THE EXISTING SEAWALL, AND FOR USE,  
MAINTENANCE, AND REPAIR OF THE EXISTING IMPROVEMENTS  
CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the  
Board of Land and Natural Resources to issue a term, nonexclusive  
easement covering a portion of state submerged lands fronting the  
property identified as tax map key: (1) 4-7-024: seaward of 022,  
Kaalaea, Koolaupoko, Oahu.

Your Committee finds that the owner of a seawall at Kaalaea,  
Koolaupoko, Oahu, requested to resolve the encroachment of the  
seawall into state submerged lands. At its meeting of September  
14, 2012, under agenda item D-15, the Board of Land and Natural  
Resources approved the grant of a fifty-five-year non-exclusive  
easement to resolve the encroachment. Your Committee further  
finds that this measure satisfies the requirements of section 171-  
53, Hawaii Revised Statutes, which requires legislative approval  
by concurrent resolution prior to the leasing of state submerged  
lands.

As affirmed by the record of votes of the members of your  
Committee on Ways and Means that is attached to this report, your



Committee concurs with the intent and purpose of S.C.R. No. 22 and recommends its adoption.
