The purpose and intent of this measure is to seek the
approval of the Legislature by concurrent resolution of a Board of
Land and Natural Resources action for the maintenance and repair
of an existing seawall, and for use, maintenance, and repair of
the existing improvements constructed thereon, located at Kaalaea,
Koolaupoko, Oahu.


Your Committee received testimony in support of this measure

This measure authorizes the Department of Land and Natural
Resources to issue a term, non-exclusive easement covering a
portion of state submerged lands fronting the property identified
as Tax Map Key: (1) 4-7-024:seaward of 022, Kaalaea, Koolaupoko,
Oahu, for the maintenance and repair of the existing seawall, and
for use, maintenance, and repair of the existing improvements
constructed thereon pursuant to section 171-53, Hawaii Revised
Statutes.
