Your Committee on Public Safety, Intergovernmental and
Military Affairs, to which was referred S.C.R. No. 26 entitled:

"SENATE CONCURRENT RESOLUTION ENCOURAGING THE DEPARTMENT OF
PUBLIC SAFETY TO CONTINUE AND EXPAND ITS STRUCTURED COMMUNITY
PLACEMENT PROGRAMS,"

begs leave to report as follows:

The purpose and intent of this measure is to encourage the
Department of Public Safety to continue and expand its structured
community placement programs that assist the transition of
formerly incarcerated persons into the community.

Your Committee received testimony in support of this measure
from the Department of Public Safety, Community Alliance on
Prisons, American Civil Liberties Union of Hawaii, and seven
individuals.

Your Committee finds that structured community placement
programs are cost-effective and afford formerly incarcerated
individuals important opportunities to reconnect with their
families, seek employment, and successfully transition to the
community. These programs are particularly effective for non-
violent female inmates, many of whom are the primary caregivers of
their children.

As affirmed by the record of votes of the members of your
Committee on Public Safety, Intergovernmental and Military Affairs
that is attached to this report, your Committee concurs with the



intent and purpose of S.C.R. No. 26 and recommends that it be referred to the Committee on Ways and Means.


