
A BILL FOR AN ACT

RELATING TO TEACHERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 302A-706, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) There is established within the department the
4 teacher national board certification incentive program to
5 recognize and support exemplary teaching practice by supporting
6 public school teachers who have achieved national board
7 certification under the certification program of the National
8 Board for Professional Teaching Standards. The teacher national
9 board certification incentive program shall provide:

- 10 (1) A \$5,000 bonus per year for each public school teacher
11 who maintains current national board certification;
- 12 (2) \$1,500 upon completing the certification program of
13 the National Board for Professional Teaching
14 Standards;
- 15 (3) A reimbursement of the remainder of the national board
16 certification application fee upon achievement of
17 national board certification; and




- 1 (4) An additional \$5,000 bonus per year for each public
- 2 school teacher who maintains current national board
- 3 certification and who teaches at:
- 4 (A) A school that is in restructuring under the No
- 5 Child Left Behind Act, Public Law 107-110;
- 6 (B) A school with a high turnover rate, as determined
- 7 by the department;
- 8 (C) A school that is not making adequate yearly
- 9 progress, but is not in restructuring under the
- 10 No Child Left Behind Act, Public Law 107-110;
- 11 [~~or~~]
- 12 (D) A hard-to-fill school, as determined by the
- 13 department [~~-~~]; or
- 14 (E) A school in a priority or superintendent's zone,
- 15 or other similar designation, as determined by
- 16 the department."

17 SECTION 2. Statutory material to be repealed is bracketed
 18 and stricken. New statutory material is underscored.

19 SECTION 3. This Act shall take effect upon its approval.
