
HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS TO ISSUE AN INTERPRETATION THAT INCLUDES EMAIL ADDRESSES IN THE OVERALL MEANING OF "CURRENT ADDRESSES" OF CONDOMINIUM ASSOCIATION MEMBERS PURSUANT TO SECTIONS 514A-83.3 AND 514B-153, HAWAII REVISED STATUTES.

1 WHEREAS, clarity is needed on the undefined meaning of
2 "current addresses" of condominium association members pursuant
3 to sections 514A-83.3 and 514B-153, Hawaii Revised Statutes; and
4

5 WHEREAS, some condominium association members interpret the
6 meaning of "current addresses" to include email addresses, and
7 this unresolved issue is causing friction among members, boards
8 of directors, and management companies; and
9

10 WHEREAS, resident managers are statutorily required to keep
11 a record of the current addresses of condominium association
12 members and to provide a copy of the record, upon request of and
13 at cost to, a member to use for specified association purposes;
14 and
15

16 WHEREAS, current law does not specify that an email address
17 is an acceptable form of a current address of a condominium
18 association member, and this lack of clarification is
19 frustrating members who want to use email to share time-
20 sensitive, association-related information with other members;
21 and
22

23 WHEREAS, modern email technology is inexpensive, fast, and
24 efficient, and will help expedite the sharing of information
25 between condominium association members who need to make
26 informed decisions on association matters; and
27

28 WHEREAS, out-of-state condominium association members are
29 sometimes the last members to receive association-related



1 information via traditional mail carriers, and these members
2 would benefit from faster, email transmissions; and
3

4 WHEREAS, the Legislature already authorizes the release of
5 a condominium association member's residence or business
6 address, which some members consider more private than a common,
7 widely-used email address; and
8

9 WHEREAS, condominium association members often use
10 traditional mail carriers to deliver association-related
11 information between each other and some members consider this
12 delivery method unfair, expensive, and inefficient for an in-
13 house task that can be done better with email; and
14

15 WHEREAS, sections 514A-83.3 and 514B-153, Hawaii Revised
16 Statutes, are outdated and need to be clarified for the benefit
17 of condominium association members who need to share timely,
18 association-related information with other members; and
19

20 WHEREAS, condominium association members stated that
21 clarification from the Department of Commerce and Consumer
22 Affairs on whether the undefined meaning of "current addresses"
23 encompasses email addresses would help to resolve this issue
24 without the need for statutory amendments; now, therefore,

26 BE IT RESOLVED by the House of Representatives of the
27 Twenty-seventh Legislature of the State of Hawaii, Regular
28 Session of 2014, the Senate concurring, that the Department of
29 Commerce and Consumer Affairs is urged to issue an
30 interpretation to allow the inclusion of email addresses in the
31 overall meaning of "current addresses" of condominium
32 association members pursuant to sections 514A-83.3 and 514B-153,
33 Hawaii Revised Statutes; and

35 BE IT FURTHER RESOLVED that certified copies of this
36 Concurrent Resolution be transmitted to the Director of Commerce
37 and Consumer Affairs and the President of the Hawaii Chapter of
38 the Community Associations Institute.
