Sir:

Your Committee on Judiciary, to which was referred H.B. No. 1660 entitled:

"A BILL FOR AN ACT RELATING TO SIDEWALKS,"

begs leave to report as follows:

The purpose of this measure is to include in the offense of obstruction:

- The provision of less than one meter of space for (1)passage on any paved public sidewalk, except as authorized by law; and
- (2) Failure to obey a reasonable request or order by a law enforcement officer to cease any activity that does not meet the one meter requirement above.

The Pacific Alliance to Stop Slavery and a few individuals testified in opposition of this measure. The Department of Transportation provided comments.

Your Committee has amended this measure by making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Judiciary that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 1660, as amended herein, and recommends that it pass Second
