Madam:

Your Committee on Ways and Means, to which was referred
S.C.R. No. 18 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE
SUBMERGED LANDS AT NIU, HONOLULU, OAHU, FOR THE MAINTENANCE
AND REPAIR OF THE EXISTING SEAWALL AND STEPS, AND FOR USE,
MAINTENANCE, AND REPAIR OF THE EXISTING IMPROVEMENTS
CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
Board of Land and Natural Resources to issue a term, non-exclusive
easement covering certain state submerged lands.

Specifically, the measure authorizes an easement for state
submerged lands at Niu, Honolulu, Oahu, for the maintenance and
repair of the existing seawall and steps, and for use,
maintenance, and repair of the existing improvements constructed
thereon.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.

Your Committee finds that section 171-53, Hawaii Revised
Statutes, requires the Board of Land and Natural Resources to
obtain the prior authorization of the Legislature by concurrent
resolution in order to issue the easement. Your Committee further



finds that authorizing the issuance of the easement for the specified state submerged lands would facilitate the use, maintenance, and repair of the specified seawall and related improvements.
