
A BILL FOR AN ACT

RELATING TO THE MILK CONTROL SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 157-29, Hawaii Revised Statutes, is
2 repealed.

3 ~~["§157-29] Milk control special fund. There is~~
4 ~~established the milk control special fund to be administered by~~
5 ~~the board of agriculture. All moneys received by the board of~~
6 ~~agriculture as application fees and for licenses or otherwise~~
7 ~~under this chapter, and any state appropriations or other moneys~~
8 ~~made available to carry out the purposes of this chapter, shall~~
9 ~~be deposited into the special fund. All interest earned or~~
10 ~~accrued on moneys deposited in the special fund shall become~~
11 ~~part of the special fund. Moneys in the special fund shall be~~
12 ~~expended to cover all costs of administering this chapter~~
13 ~~including but not limited to the costs of salaries, fringe~~
14 ~~benefits, operating expenses, equipment, motor vehicles,~~
15 ~~contracts for services, and promotional expenses. Moneys in the~~
16 ~~special fund may be transferred to the general fund for salaries~~
17 ~~and fringe benefits of other state employees assisting in~~
18 ~~administering this chapter and other related costs. A reserve~~



1 shall be maintained in the special fund to cover contingency
2 costs including but not limited to accrued vacation leave,
3 unemployment insurance, and workers' compensation."]

4 SECTION 2. The director of finance shall transfer all
5 unexpended and unencumbered balances remaining as of June 30,
6 2015, in the milk control special fund established by section
7 157-29, Hawaii Revised Statutes, to the credit of the general
8 fund. Additionally, any revenues scheduled to be paid into the
9 milk control special fund after June 30, 2015, shall be paid to
10 the credit of the general fund.

11 SECTION 3. This Act shall not affect rights and duties
12 that matured, penalties that were incurred, and proceedings that
13 were begun before its effective date.

14 SECTION 4. Statutory material to be repealed is bracketed
15 and stricken.

16 SECTION 5. This Act shall take effect on June 30, 2015.
