BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I
2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, budgeting (BUF 102) the following sums, or so much
5 thereof as may be necessary, to fund for fiscal
6 biennium 2015-2017 all collective bargaining cost items in the
7 agreement negotiated with the exclusive bargaining
8 representative of collective bargaining unit (2):

2 shall be paid wholly or proportionately, as the case may be,
3 from the respective funds.

4 SECTION 12. Funds appropriated or authorized by this Act
5 that are not expended or encumbered by June 30, 2016, and June
6 30, 2017, of the respective fiscal years, shall lapse as of
7 those dates.

8 SECTION 13. This Act, upon its approval, shall take effect
9 on July 1, 2115.
