MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, budgeting (BUF 102) the following sums, or so much
5 thereof as may be necessary, to fund for fiscal
6 biennium 2015-2017 all collective bargaining cost items in the
7 agreement negotiated with the exclusive bargaining
8 representative of collective bargaining unit (3):

5 shall be paid wholly or proportionately, as the case may be,
6 from the respective funds.

7 SECTION 12. Funds appropriated or authorized by this Act
8 that are not expended or encumbered by June 30, 2016, and
9 June 30, 2017, of the respective fiscal years, shall lapse as of
10 those dates.

11 SECTION 13. This Act, upon its approval, shall take effect
12 on July 1, 2115.
