# A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 **PART I**

2 SECTION 1. Chapter 291C, Hawaii Revised Statutes, is  
3 amended by adding a new section to be appropriately designated  
4 and to read as follows:

5 **"§291C- Operation of a motor vehicle near a bicycle**  
6 **prohibited.** The driver of a motor vehicle shall not operate the  
7 motor vehicle within one meter of a moving bicycle."

8 **PART II**

9 SECTION 2. There is appropriated out of the general  
10 revenues of the State of Hawaii the sum of \$500,000 or so much  
11 thereof as may be necessary for fiscal year 2015-2016 and the  
12 same sum or so much thereof as may be necessary for fiscal year  
13 2016-2017 for a grant-in-aid to the department of transportation  
14 services of the city and county of Honolulu to operate a van  
15 pool program on the island of Oahu; provided that:

16 (1) The city and county of Honolulu department of  
17 transportation services shall submit to the state  
18 department of transportation and legislature a plan



1 for the use of the grant before any expenditure or  
2 obligation is made for the van pool program. The plan  
3 shall be submitted at least thirty days prior to the  
4 city and county of Honolulu department of  
5 transportation services expending or obligating any  
6 portion of the grant; and

- 7 (2) The city and county of Honolulu department of  
8 transportation services shall submit two reports to  
9 the state department of transportation and legislature  
10 on the use of the grant with statistics on  
11 expenditure, usage, benefits, and costs. The first  
12 report shall cover the fiscal period from July to  
13 December 2015, and shall be submitted prior to the  
14 convening of the regular session of 2016. The second  
15 report shall cover fiscal year 2016-2017 and shall be  
16 submitted at least twenty days prior to the convening  
17 of the regular session of 2018.

18 The sums appropriated shall be expended by the department  
19 of transportation for the purposes of this Act.

20 **PART III**

21 SECTION 3. New statutory material is underscored.



1 SECTION 4. This Act shall take effect upon its approval;  
2 provided that section 2 shall take effect on July 1, 2015.



**Report Title:**

Motor Vehicles; Bicycles; Proximity; Grant-in-Aid; Van Pool

**Description:**

Prohibits a motor vehicle from being operated within one meter of a moving bicycle. Appropriates funds for a grant-in-aid to the city and county of Honolulu to operate a van pool program on Oahu; subject to certain reporting requirements. (SD1)
