
SENATE CONCURRENT RESOLUTION

REQUESTING AN UPDATE OF THE STATE HOUSING FUNCTIONAL PLAN.

1 WHEREAS, the Hawaii State Planning Act, codified as chapter
2 226, Hawaii Revised Statutes, outlines a long-range guide for
3 Hawaii's future and establishes a statewide planning system; and
4

5 WHEREAS, section 226-55, Hawaii Revised Statutes, requires
6 the state agency primarily responsible for a given functional
7 area to prepare a functional plan for that area; and
8

9 WHEREAS, functional plans identify priority issues in the
10 functional area and establish objectives, policies, and
11 implementing actions to address those priority issues; and
12

13 WHEREAS, the Housing Finance and Development Corporation
14 prepared the State Housing Functional Plan in 1989, which set
15 out a comprehensive plan for the development, preservation, and
16 management of housing in the State; and
17

18 WHEREAS, at the request of the Legislature, the Housing
19 Finance and Development Corporation updated the State Housing
20 Functional Plan in 1990 to address the housing needs for all
21 income levels, including the homeless; and

23 WHEREAS, the State's housing requirements have changed
24 since the State Housing Functional Plan was last updated,
25 including the need for housing in relation to transit-oriented
26 development; now, therefore,

28 BE IT RESOLVED by the Senate of the Twenty-eighth
29 Legislature of the State of Hawaii, Regular Session of 2015, the
30 House of Representatives concurring, that the Governor, in
31 coordination with the Office of Planning and the Hawaii Housing



1 Finance and Development Corporation, is requested to update the
2 State Housing Functional Plan; and
3

4 BE IT FURTHER RESOLVED that the Governor, in coordination
5 with the Office of Planning and the Hawaii Housing Finance and
6 Development Corporation, is requested to submit a report of its
7 findings and recommendations, including any proposed
8 legislation, to the Legislature no later than twenty days prior
9 to the convening of the Regular Session of 2016; and

11 BE IT FURTHER RESOLVED that certified copies of this
12 Concurrent Resolution be transmitted to the Governor, Director
13 of Human Services, Chairperson of the Hawaiian Homes Commission,
14 Executive Director of the Hawaii Public Housing Authority,
15 Director of the Office of Planning, Executive Director of the
16 Hawaii Housing Finance and Development Corporation, Governor's
17 Coordinator on Homelessness, Mayor of the City and County of
18 Honolulu, Mayor of the County of Kauai, Mayor of the County of
19 Maui, Mayor of the County of Hawaii, Director of the Kauai
20 County Housing Agency, Director of the Department of Community
21 Services for the City and County of Honolulu, Director of the
22 Department of Housing and Human Concerns for the County of Maui,
23 and Housing Administrator of the Office of Housing and Community
24 Development for the County of Hawaii.
