entitled:

"A BILL FOR AN ACT RELATING TO AFFORDABLE HOUSING ON HAWAIIAN  
HOME LANDS,"

begs leave to report as follows:

The purpose of this measure is to make permanent provisions  
of two previous Acts directing the counties to issue affordable  
housing credits to the Department of Hawaiian Home Lands, upon  
request, for affordable housing developed on Hawaiian Home Lands.

The Department of Hawaiian Home Lands testified in support of  
this measure. The Department of Planning and Permitting of the  
City and County of Honolulu testified in opposition to this bill.

Your Committee has amended this measure by:


- (1) Extending the sunset date for both provisions concerning  
affordable housing credits to July 1, 2021, instead of  
repealing the sunset;
- (2) Changing the effective date to July 1, 2050; and
- (3) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.


