The purpose of this measure is to address the shortage of
space for state agencies in the Wailuku State Office Building and
Old Courthouse Building by:

- (1) Requiring the Department of Accounting and General
Services to develop a comprehensive Wailuku State Office
Master Plan and report its findings to the Legislature
before the Regular Session of 2016; and
- (2) Appropriating funds for the development of the
comprehensive Wailuku State Office Master Plan.

The Department of Accounting and General Services provided
comments on this measure.

Your Committee has amended this measure by changing the
appropriation amount to an unspecified sum and making technical,
nonsubstantive amendments for clarity, consistency, and style.
