Your Committee on Ways and Means, to which was referred
S.C.R. No. 16 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE
SUBMERGED LANDS AT HAUULA, KOOLAULOA, OAHU, FOR THE USE,
MAINTENANCE, AND REPAIR OF PORTION OF THE EXISTING RESIDENCE,
FOUNDATION, AND LANAI CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
Board of Land and Natural Resources to issue a term, non-exclusive
easement covering a portion of state submerged lands fronting the
property identified as Tax Map Key: (1) 5-4-010: seaward of 009,
Hauula, Koolauloa, Oahu, for the use, maintenance, and repair of a
portion of the existing family residence, foundation, and lanai
constructed thereon.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.

Your Committee finds that the Board of Land and Natural
Resources has approved the issuance of a 55-year non-exclusive
easement to property owners Scott and Beverly Miyasaki, and Tracy
Lindo, to resolve the encroachments of a family residence, its
foundation, and lanai on state submerged lands fronting the
property identified as Tax Map Key: (1) 5-4-010: seaward of 009,
Hauula, Koolauloa, Oahu. Accordingly, your Committee finds that
the issuance of the easement is in the best interest of the State.



As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 16 and recommends its adoption.
