The purpose of this measure is to authorize the Board of Land
and Natural Resources to issue a term, non-exclusive easement
covering a portion of state submerged lands fronting the property
identified as Tax Map Key: (1) 4-4-022: seaward of 007, Kaneohe,
Koolauoko, Oahu, for the use, maintenance, and repair of the
existing CRM wall, landscaping area, floating dock, and concrete
pier purposes constructed thereon.

The Department of Land and Natural Resources provided

Committees on Water & Land and Ocean, Marine Resources, & Hawaiian

be referred to the Committee on Finance.


