Your Committee on Education, to which was referred S.R.  
No. 118, S.D. 1, entitled:

"SENATE RESOLUTION REQUESTING THE EXECUTIVE OFFICE ON AGING  
TO ESTABLISH A WORKING GROUP TO REVIEW ADULT EDUCATION  
SERVICES AND THE POTENTIAL TO PROVIDE NEW LEARNING  
OPPORTUNITIES TO SENIOR CITIZENS,"

begs leave to report as follows:

The purpose and intent of this measure is to request the  
Executive Office on Aging to convene an adult education working  
group to review adult education services and opportunities  
presently offered to seniors, consider whether it would be  
effective to consolidate some programs in order to provide new  
learning opportunities, and explore other potential education  
programs that might be beneficial to seniors.

Your Committee received testimony in support of this measure  
from two individuals.

Your Committee finds that funding for education services for  
senior citizens is limited, and must be used efficiently.  
Eliminating redundancy may free up funds to allow a more diverse  
offering of learning opportunities for seniors. Bringing together  
senior citizen support service providers to discuss current  
services, determine whether consolidation of programs may be  
appropriate, and explore potential new programs will help the  
network of services be more efficient and meet a broader range of  
needs.
