RELATING TO PILOTAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 462A-3, Hawaii Revised Statutes, is 2 amended to read as follows:

"§462A-3 Powers and duties of the director. In addition
to any other powers and duties authorized by law, the director
shall:

(1) Grant licenses to port pilots and deputy port pilots pursuant to this chapter, when the need arises;

(2) Adopt, amend, or repeal rules in accordance with chapter 91 as may be necessary to carry out the purposes of this chapter which are to provide for maximum efficiency in navigating vessels entering or leaving the waters of this State; maintain a pilotage system devoted to the preservation, and protection of lives, property, and vessels entering or leaving waters of the State; and ensure an adequate supply of qualified pilots in aid of commerce and navigation;

1	(3)	Develop appropriate standards for licensure and
2		renewal of licensure to maintain an adequate supply of
3.		pilots based on the needs of users of pilotage
4		services or the department of transportation's harbors
5		division. Licensing requirements shall include

· 7		persons applying for full port pilot, or deputy port
8		pilot licenses are qualified;
9	(4)	Enforce this chapter and rules adopted pursuant
10		thereto;
11	(5)	Suspend, revoke or deny the issuance of any license
12		for any cause prescribed by this chapter, or for any
13		violation of the rules;
14	(6)	Investigate any person for violations of any
15		provisions of this chapter;
16	(7)	Adopt methods to improve disciplinary and enforcement
17		programs against violations of this chapter; and
18	(8)	Do all things reasonable, necessary, and expedient to
19		insure proper and safe pilotage and to facilitate the
20		efficient administration of this chapter."

- 1 SECTION 2. Section 462A-6, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§462A-6 Duration and renewal of license. All licenses
- 4 shall expire on June 30 of even-numbered years. All applicants
- 5 for renewal of license shall submit a renewal application
- 6 pursuant to section 436B-13 and comply with all applicable rules
- 7 of the department. No applicant shall be denied a renewal of
- 8 the applicant's license, except as provided in this chapter, as
- 9 long as the applicant possesses the qualifications established
- 10 by the department and remains in active service as a pilot in
- 11 the State."
- 12 SECTION 3. Section 462A-18, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§462A-18 Vessels required to take a pilot. Every vessel
- 15 [involved in trade or commerce], other than an exempt vessel,
- 16 entering or departing from any port in or traversing the waters
- 17 of the State designated as pilotage waters shall employ a pilot
- 18 licensed under this chapter; provided that a vessel declared by
- 19 the director of transportation to be in immediate danger of
- 20 destruction or which poses an immediate hazard to public safety

3	SECT	ION 4. Section 462A-19, Hawaii Revised Statutes, is
4	amended to	o read as follows:
5	"§46	2A-19 Exempt vessels. This chapter does not apply to:
6	(1)	Any vessel required by the laws of the United States
7		of America to be under the direction and control of a
8		federally licensed pilot;
9	(2)	Public vessels of the United States of America;
10	(3)	Fishing vessels that have been issued a fishery
11		license or appropriately endorsed registry under the
12		laws of the United States of America; [ex]
13	(4)	Tugs or towboats of 1,600 gross tons or less which are
14		registered in the United States if the master, mate,
15		or operator is licensed in the United States and has
16		made a minimum of six round trips into and out of the
17		pilotage water which the vessel is traversing [-]; or
18	<u>(5)</u>	Vessels under 300 gross tons.
19	This	section provides minimum pilotage requirements, and is
20	not inten	ded to negate the department of transportation's
21	responsib	ility for the safety of all ports and shore waters in

- 1 the State, nor does it limit the department's right to require
- 2 additional pilotage should that department determine it is
- 3 necessary to ensure safety in the ports or shore waters of the
- 4 State."
- 5 SECTION 5. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect upon its approval.
