## A BILL FOR AN ACT

RELATING TO INFRASTRUCTURE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 46-80.1, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:  
3           "(a) Any county having a charter may enact an ordinance,  
4 and may amend the same from time to time, providing for the  
5 creation of community facilities districts to finance special  
6 improvements in the county. The special improvements may be  
7 provided and financed under the ordinance. The county shall  
8 have the power to levy and assess a special tax on property  
9 located in a district to finance the special improvements and to  
10 pay the debt service on any bonds issued to finance the special  
11 improvements. The county may issue and sell bonds to provide  
12 funds for the special improvements[-], or , if requested by the  
13 county, the State may issue and sell revenue bonds under section  
14 201H-72. Bonds issued to provide funds for the special  
15 improvements may be either: bonds secured only by the  
16 properties included in the district and/or the special taxes  
17 thereon, or bonds payable from general taxes and/or secured by



1 the general taxing power of the county. If the bonds are  
2 secured only by the properties included in the district and/or  
3 the special taxes thereon, the bonds shall be issued according  
4 and subject to the provisions of the ordinance. If the bonds  
5 are payable from general taxes or secured by the general taxing  
6 power, the bonds shall be issued according and subject to  
7 chapter 47."

8 SECTION 2. Section 201H-72, Hawaii Revised Statutes, is  
9 amended to read as follows:

10 "§201H-72 Issuance of bonds for the development of  
11 infrastructure. Without limiting section 201H-71, the  
12 corporation, pursuant to and in accordance with this subpart or  
13 section 46-80.1(a), is authorized to issue bonds for the purpose  
14 of financing the development of infrastructure for land owned by  
15 the corporation or for land owned by an eligible developer as  
16 defined in section 201H-32 whose housing project approval by a  
17 state or county agency requires the construction of affordable  
18 housing."

19 SECTION 3. Statutory material to be repealed is bracketed  
20 and stricken. New statutory material is underscored.
