
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII ACCOUNTING AND FINANCIAL
MANAGEMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the University of
2 Hawaii has maintained a separate accounting system since 1986,
3 which has been compatible with both Hawaii accounting system
4 requirements and generally accepted accounting principles. The
5 legislature further finds that the University of Hawaii has
6 recently upgraded its accounting system through its
7 participation in the Kualii financial system consortium, a
8 university-based financial management software that better meets
9 the unique needs of university systems throughout the United
10 States. Since the implementation of the Kualii financial system,
11 the University of Hawaii continues to provide bi-monthly payroll
12 feeds to the department of accounting and general services, in
13 addition to routine and annual financial reports that are
14 included in the State of Hawaii annual consolidated financial
15 statements.

16 The purpose of this Act is to extend the authority of the
17 University of Hawaii to maintain a separate accounting and



1 financial management system that is compatible with the State of
2 Hawaii accounting and financial systems.

3 SECTION 2. Section 40-1, Hawaii Revised Statutes, is
4 amended by amending subsection (b) to read as follows:

5 "(b) With respect to the executive branch, except the
6 University of Hawaii until June 30, [~~2016~~,] 2019, the Hawaii
7 tourism authority, and the department of education until
8 June 30, 2015, the comptroller shall have complete supervision
9 of all accounts. The comptroller shall preaudit all proposed
10 payments of \$10,000 or more to determine the propriety of
11 expenditures and compliance with executive orders and rules that
12 may be in effect. When necessary, the comptroller shall
13 withhold approval of any payment. Whenever approval is
14 withheld, the department or agency concerned shall be promptly
15 notified. With respect to the University of Hawaii, the Hawaii
16 tourism authority, and the department of education, the
17 comptroller shall issue warrants for the release of funds for
18 the operating costs of the university, the Hawaii tourism
19 authority, or the department of education, as applicable, in
20 amounts and at times mutually agreed upon by the governor or
21 director of finance and the university, the Hawaii tourism



1 authority, or department of education, as applicable; provided
2 that:

3 (1) The amounts released shall not exceed the allotment
4 ceilings for the respective funding sources of the
5 university's or the department of education's
6 appropriations established by the governor for an
7 allotment period pursuant to section 37-34, or in the
8 case of the Hawaii tourism authority, revenues
9 received by the convention center enterprise special
10 fund and the tourism special fund pursuant to section
11 237D-6.5; and

12 (2) The comptroller may issue warrants as an advance from
13 the state treasury to the University of Hawaii, the
14 Hawaii tourism authority, and the department of
15 education to establish a checking account and provide
16 working capital in amounts and at times mutually
17 agreed upon by the governor or director of finance and
18 the University of Hawaii, the Hawaii tourism
19 authority, and the department of education.

20 The University of Hawaii and the department of education shall
21 preaudit all proposed payments of \$10,000 or more and shall



1 preaudit samples of the population of proposed payments of less
2 than \$10,000; provided that the sample size comprises at least
3 five per cent of the population, and is of a size that the chief
4 financial officers of the University of Hawaii and the
5 department of education, as applicable, determine appropriate,
6 to determine the propriety of expenditures and compliance with
7 applicable laws, executive orders, and rules. The Hawaii
8 tourism authority shall preaudit all proposed payments to
9 determine the propriety of expenditures and compliance with
10 applicable laws, executive orders, and rules as may be in
11 effect. The University of Hawaii, the Hawaii tourism authority,
12 and the department of education shall make disbursements for
13 operating expenses from the amounts released by the comptroller
14 and maintain records and documents necessary to support those
15 disbursements at times mutually agreed upon by the university
16 president, the executive director of the Hawaii tourism
17 authority, or the superintendent of education, as applicable,
18 and the comptroller; provided that when requested by the
19 university, the Hawaii tourism authority, or department of
20 education, the comptroller shall make all disbursements for the
21 university, the Hawaii tourism authority, or department of



1 education, as applicable, subject to available allotment. Funds
2 released pursuant to this section shall be deposited by the
3 university, the Hawaii tourism authority, or department of
4 education, as applicable, in accordance with the provisions
5 applicable to the director of finance by chapter 38. Except for
6 moneys deposited by the Hawaii tourism authority in the
7 convention center enterprise special fund pursuant to section
8 201B-8, and in the tourism special fund pursuant to section
9 201B-11, any interest earned on the deposit of funds released
10 pursuant to this section shall be deposited in the state
11 treasury at the end of each fiscal year."

12 SECTION 3. Section 40-2, Hawaii Revised Statutes, is
13 amended by amending subsection (a) to read as follows:

14 "(a) The accounting system installed by the commission on
15 public accountancy under Act 181, Session Laws of Hawaii 1923,
16 as amended by Act 220, Session Laws of Hawaii 1925, for use in
17 the offices of the comptroller, director of finance,
18 departmental and agency services of the State, and the auditors,
19 treasurers, departmental and agency services of the several
20 counties shall be the accounting and reporting systems of the
21 State and counties; provided that the University of Hawaii,



1 until June 30, [~~2016-7~~] 2019, may install a different accounting
 2 system that shall be in conformity with generally accepted
 3 accounting principles as applied to colleges and universities;
 4 and provided further that the department of education, until
 5 June 30, 2011, may install a different accounting system that
 6 shall be in conformity to generally accepted accounting
 7 principles. The comptroller shall make [~~such~~] changes and
 8 modifications in the accounting system [~~as shall from time to~~
 9 ~~time appear to be~~] that are in the best interest of the State
 10 and counties."

11 SECTION 4. Section 40-4, Hawaii Revised Statutes, is
 12 amended to read as follows:

13 "**§40-4 Publication of statements.** The comptroller shall
 14 prepare and submit to the governor, immediately following the
 15 close of each fiscal year, a statement of income and expenditure
 16 by funds, showing the principal sources of revenue, the function
 17 or purpose for which expenditures were made, together with a
 18 consolidated statement showing similar information for all
 19 funds; also a statement showing the balance in each fund at the
 20 beginning of the fiscal year, plus the receipts, minus the
 21 disbursements, and the balance on hand at the close of the



1 fiscal year after deducting outstanding warrants and vouchers.
2 The comptroller may request all agencies, the judiciary, the
3 University of Hawaii until June 30, [~~2016~~] 2019, the Hawaii
4 tourism authority, the department of education until June 30,
5 2011, and the legislature to provide such information as may be
6 required for the preparation of statements."

7 SECTION 5. Section 40-6, Hawaii Revised Statutes, is
8 amended to read as follows:

9 "**§40-6 Approval of business and accounting forms.** The
10 comptroller shall determine the forms required to adequately
11 supply accounting and statistical data for the state government.
12 The comptroller shall require heads of departments and
13 establishments of the state government to submit proposed new
14 forms or proposed changes in current business and accounting
15 forms for review and approval before ordering the same printed;
16 except that the University of Hawaii until June 30, [~~2016~~]
17 2019, the Hawaii tourism authority, and the department of
18 education until June 30, 2011, shall be subject to this
19 requirement only with respect to uniform business and accounting
20 forms of statewide use in the State's accounting system. All
21 standard state forms shall be classified, numbered, and



1 standardized in design, dimensions, color, and grade of paper
2 and recorded in a catalogue of accounting and statistical forms
3 by the comptroller."

4 SECTION 6. Section 40-58, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "§40-58 In favor of assignees. No assignment of moneys by
7 a person to whom the State is directly indebted shall be
8 effective unless the assignment is first approved by the
9 comptroller or, in the case of the University of Hawaii until
10 June 30, [~~2016~~] 2019, and the department of education until
11 June 30, 2011, by their respective chief financial officers.
12 The comptroller or the chief financial officers of the
13 University of Hawaii and the department of education may
14 prescribe the form for an assignment [~~7~~] and may approve the
15 assignment within a reasonable time period if, in their
16 respective discretion, the rights or obligations of the State [~~7~~]
17 or the University of Hawaii, or the department of education
18 under any contract or other undertaking or under any law, rule,
19 or order by a competent authority will not be prejudiced
20 thereby. Upon approval of the assignment, the comptroller or
21 the respective chief financial officers of the University of



1 Hawaii and the department of education shall draw a warrant
2 payable to the assignee. Except as to contracts encumbered by
3 the comptroller[7] or the University of Hawaii, or the
4 department of education, each expending agency, upon
5 notification of the comptroller's approval of an assignment,
6 shall prepare a claim for payment in accordance with the terms
7 of the assignment."

8 SECTION 7. Section 40-81, Hawaii Revised Statutes, is
9 amended to read as follows:

10 "**§40-81 Report by agencies receiving special moneys.** All
11 state officers, departments, boards, bureaus, commissions, or
12 agencies collecting or receiving any moneys not required by law
13 to be deposited in the state treasury shall report to the
14 comptroller all receipts and disbursements on account thereof
15 for each quarterly period of the calendar year not later than
16 the fifteenth day following the end of each quarterly period on
17 such forms and under such rules as may be prescribed by the
18 comptroller; provided that with respect to all moneys held
19 outside the state treasury by the University of Hawaii until
20 June 30, [~~2016~~] 2019, or the department of education until
21 June 30, 2011, pursuant to the authority granted to the



1 university and the department of education by this chapter, the
2 University of Hawaii and the department of education shall
3 report to the comptroller all transactions for each quarterly
4 period not later than the fifteenth day following the end of
5 each quarterly period on [such] forms and under [such] rules as
6 may be prescribed by the comptroller."

7 SECTION 8. Act 58, Session Laws of Hawaii 2004, as amended
8 by section 50 of Act 22, Session Laws of Hawaii 2005, as amended
9 by section 1 of Act 306, Session Laws of Hawaii 2006, as amended
10 by section 12 of Act 5, Special Session Laws of Hawaii 2009, as
11 amended by section 5 of Act 102, Session Laws of Hawaii 2010, is
12 amended by amending section 14 to read as follows:

13 "SECTION 14. This Act shall take effect upon its approval;
14 provided that:

15 (1) The amendments made to sections 40-1, 40-4, and 40-6,
16 Hawaii Revised Statutes, by part I of this Act shall
17 not be repealed when those sections are reenacted on
18 June 30, 2006, by section 1 of Act 137, Session Laws
19 of Hawaii 2005;

20 (2) Sections 3, 4, 5, 6, and 7 of part I shall be repealed
21 on June 30, 2015, and:



1 (A) Sections 201B-2 and 201B-11, Hawaii Revised
 2 Statutes, shall be reenacted in the form in which
 3 they read on May 5, 2004; except that the
 4 amendments made by Act 5, Special Session Laws of
 5 Hawaii 2009, to section 201B-2, Hawaii Revised
 6 Statutes, and subsection (c) of section 201B-11,
 7 Hawaii Revised Statutes, shall not be repealed;
 8 and

9 (B) Sections 40-1, 40-4, and 40-6, Hawaii Revised
 10 Statutes, shall be reenacted in the form in which
 11 they read on [~~June 30, 1986,~~] May 5, 2004; and

12 (3) Section 9 shall take effect on July 1, 2004."

13 SECTION 9. Act 124, Session Laws of Hawaii 2010, is
 14 amended by amending section 15 to read as follows:

15 "SECTION 15. This Act, upon its approval, shall take
 16 effect retroactive to April 30, 2010; provided that:

17 (1) Part II shall only take effect upon the repeal and
 18 reenactment of sections 40-1, 40-4, and 40-6, Hawaii
 19 Revised Statutes, on June 30, 2010, pursuant to Act
 20 58, Session Laws of Hawaii 2004, as amended; and



1 (2) Part III shall only take effect upon the repeal of
2 paragraph (2)(B) of section 14 of Act 58, Session Laws
3 of Hawaii 2004, as amended, pursuant to an Act of the
4 2010 legislature; or in the absence of that repeal,
5 upon the extension of the June 30, 2010, repeal date
6 in paragraph (2) of section 14 of Act 58, Session Laws
7 of Hawaii 2004, as amended, pursuant to an Act of the
8 2010 legislature[-]; provided further that the
9 amendments to sections 40-1, 40-4, and 40-6, Hawaii
10 Revised Statutes, by part III shall not be repealed
11 when those sections are repealed and reenacted
12 pursuant to section 5 of Act 102, Session Laws of
13 Hawaii 2010."

14 SECTION 10. Act 161, Session Laws of Hawaii 2010, is
15 amended by amending section 8 to read as follows:

16 "SECTION 8. This Act, upon its approval, shall take effect
17 retroactive to April 30, 2010; provided that:

18 (1) Part II shall only take effect upon the repeal and
19 reenactment of section 40-1, Hawaii Revised Statutes,
20 on June 30, 2010, pursuant to Act 58, Session Laws of
21 Hawaii 2004, as amended; and



1 (2) Part III shall only take effect upon the repeal of
2 paragraph (2)(B) of section 14 of Act 58, Session Laws
3 of Hawaii 2004, as amended, pursuant to an Act of the
4 2010 legislature; or in the absence of that repeal,
5 upon the extension of the June 30, 2010, repeal date
6 in paragraph (2) of section 14 of Act 58, Session Laws
7 of Hawaii 2004, as amended, pursuant to an Act of the
8 2010 legislature[-]; provided that the amendment to
9 section 40-1, Hawaii Revised Statutes, by part III
10 shall not be repealed when that section is repealed
11 and reenacted pursuant to section 5 of Act 102,
12 Session Laws of Hawaii 2010."

13 SECTION 11. Statutory material to be repealed is bracketed
14 and stricken. New statutory material is underscored.

15 SECTION 12. This Act shall take effect on June 29, 2050;
16 provided that the amendments made to sections 40-1(b), 40-4, and
17 40-6, Hawaii Revised Statutes, shall not be repealed when those
18 sections are repealed and reenacted on June 30, 2015, pursuant
19 to section 5 of Act 102, Session Laws of Hawaii 2010.
