
SENATE CONCURRENT RESOLUTION

REQUESTING THE GOVERNOR AND DEPARTMENT OF TRANSPORTATION TO
INCLUDE IN THE 2017-2018 SUPPLEMENTAL CAPITAL IMPROVEMENT
PROGRAM REQUEST IMPROVEMENTS TO CRUISE SHIP PASSENGER
TERMINALS AT NAWILIWILI HARBOR IN KAUAI, HONOLULU HARBOR IN
OAHU, KAHULUI HARBOR IN MAUI, AND HILO HARBOR IN HAWAII.

1 WHEREAS, the Legislature enacted Act 200, Session Laws of
2 Hawaii 2008, to provide suitable harbor facilities and berthing
3 piers to ensure the efficient and timely delivery and shipment
4 of goods imported into the State; and
5

6 WHEREAS, Act 200 also included the construction of ferry
7 and passenger facilities; and
8

9 WHEREAS, Hawaii's congressional delegation consisting of
10 the late Senator Daniel Inouye, retired Senator Daniel Akaka,
11 former Congressman Neil Abercrombie, and Congresswoman Mazie
12 Hirono supported and included into Public Law, 109-59, Title IX,
13 Section 9008, the Hawaii Port Infrastructure Expansion Program,
14 Merchant Marine Act of 1936, as amended; and
15

16 WHEREAS, that congressional delegation successfully
17 allocated federal funds to the Hawaii Port Infrastructure
18 Expansion Program; and
19

20 WHEREAS, federal funds from the Hawaii Port Infrastructure
21 Expansion Program were used to design an efficient traffic flow
22 for tour buses and taxi operations and enhance the passenger
23 experience by remodeling the interior of the terminal at the
24 Pier 2 Passenger Terminal in Honolulu Harbor; and

26 WHEREAS, at the 2013 Historic Preservation Honor Awards,
27 the Historic Hawaii Foundation recognized the Pier 2 Passenger
28 Terminal Building by awarding it the Preservation Media Award



1 for its permanent exhibits and large scale original Hawaii
2 artwork; and

3
4 WHEREAS, federal funds were also used to separate inter-
5 island cargo operations and passenger tour operations at Hilo
6 Harbor; and

7
8 WHEREAS, during fiscal year (FY) 2014-2015, approximately
9 1.15 million cruise ship passengers passed through the Hawaii
10 harbor system, as compared to 1.21 million in FY 2013-2014 and
11 1.15 million in FY 2012-2013; and

12
13 WHEREAS, effective July 1, 2011, cruise ship passengers
14 were assessed a debark fee of \$5, an embark fee of \$5 at the
15 first point of entry, and an additional \$5 in-transit fee for
16 each port visit thereafter; and

17
18 WHEREAS, effective July 1, 2013, the debark and embark fees
19 increased to \$6 per passenger; and

20
21 WHEREAS, primarily due to the changes in the fee rate
22 structure, cruise ship passengers' fee revenue increased from
23 \$5.7 million in FY 2012-2013 to \$6.7 million in FY 2013-2014 and
24 to \$6.9 million in FY 2014-2015; and

25
26 WHEREAS, while the Department of Transportation has
27 increased the passengers' fees, it has not, except for the
28 improvements to Pier 2 at Honolulu Harbor, included in its
29 Capital Improvement Program the design and construction of
30 cruise ship passenger facilities for each of its major
31 commercial ports serving passenger vessels; and

32
33 WHEREAS, the Hawaii Tourism Authority is increasing its
34 market to include passenger cruise operations; and

35
36 WHEREAS, the Hawaii Tourism Authority is funding a
37 statewide vessel scheduling system for cruise line agents to
38 have online access to reserve and schedule passenger vessels at
39 the Department of Land and Natural Resources small boat harbors
40 at Kona and Lahaina and the Department of Transportation Harbors
41 Division commercial ports at Nawiliwili Harbor in Kauai,



1 Honolulu Harbor in Oahu, Kahului Harbor in Maui, and Hilo Harbor
2 in Hawaii; and

3

4 WHEREAS, the Department of Transportation is seeking to
5 support the Hawaii Tourism Authority by funding an existing
6 position to evaluate existing facilities, help create a uniform
7 visitor experience at each port of call, and support the Hawaii
8 Tourism Authority in managing the greeter program; and

9

10 WHEREAS, the Legislature recognizes and supports the
11 cooperation between the Department of Transportation and the
12 Hawaii Tourism Authority to enhance the passenger experience and
13 tourism brand; now, therefore,

14

15 BE IT RESOLVED by the Senate of the Twenty-eighth
16 Legislature of the State of Hawaii, Regular Session of 2015, the
17 House of Representatives concurring, that the Governor and
18 Department of Transportation are requested to include in the
19 2017-2018 Supplemental Capital Improvement Program request
20 improvements to cruise ship passenger terminals at Nawiliwili
21 Harbor in Kauai, Honolulu Harbor in Oahu, Kahului Harbor in
22 Maui, and Hilo Harbor in Hawaii; and

24 BE IT FURTHER RESOLVED that the Department of
25 Transportation continue to collaborate with the Hawaii Tourism
26 Authority and other state and federal entities to encourage the
27 installation of art and award winning designs that promote
28 heritage tourism and original Hawaii artwork; and

30 BE IT FURTHER RESOLVED that certified copies of this
31 Concurrent Resolution be transmitted to the members of Hawaii's
32 congressional delegation, Governor, Director of Transportation,
33 Chair of the Hawaii Tourism Authority, Mayor of Hawaii County,
34 Mayor of Kauai County, Mayor of Maui County, Chair of the Hawaii
35 County Council, Chair of the Kauai County Council, and Chair of
36 the Maui County Council.
