"A BILL FOR AN ACT RELATING TO TRAINING,"

beg leave to report as follows:

The purpose and intent of this measure is to require the
Office of Hawaiian Affairs to administer a training course on
native Hawaiian and Hawaiian rights for appropriate agencies and
employees and to require members of certain state council, board,
and commission members to complete the training.

Your Committees received testimony in support of this measure
from the Office of Hawaiian Affairs, Department of Land and
Natural Resources, Land Use Commission, Hawaiian Affairs Caucus of
the Democratic Party of Hawaii, Ewa Puuloa Hawaiian Civic Club,
King Kamehameha Hawaiian Civic Club, Association of Hawaiian Civic
Clubs, Kuaaina Ulu Auamano, Kalihi Palama Hawaiian Civic Club, Ka
Huli Ao Center, Society for Hawaiian Archaeology, and eighteen
individuals. Your Committee received testimony in opposition to
this measure from the Land Use Research Foundation of Hawaii and
Center for Hawaiian Sovereignty Studies.

Your Committees have amended this measure by:


- (1) Making this measure effective upon approval; and




- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.


