Your Committee on Transportation, to which was referred H.R. No. 118 entitled:

"HOUSE RESOLUTION URGING THE DEPARTMENT OF TRANSPORTATION SERVICES AND DEPARTMENT OF PARKS AND RECREATION OF THE CITY AND COUNTY OF HONOLULU TO CONDUCT A STUDY OF THE INTERSECTION OF MANAGERS DRIVE AND HIAPO STREET IN WAIPAHU AND RECOMMEND SAFETY MEASURES FOR THIS INTERSECTION AND THE SURROUNDING SURFACE STREETS,"
