# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are authorized from the source of funding  
3 indicated below to collective bargaining statewide (BUF 102) the  
4 following sums or so much thereof as may be necessary to fund  
5 for fiscal biennium 2015-2017 all collective bargaining cost  
6 items in the agreement negotiated with the exclusive bargaining  
7 representative of collective bargaining unit (11):

8	<u>FY 2015-2016</u>	<u>FY 2016-2017</u>
9 Special Funds	\$8,447	\$33,786

10 SECTION 2. Funds authorized by this part shall be allotted  
11 by the director of finance to the appropriate state departments  
12 for expenditure in the respective fiscal year for the purposes  
13 of this part.

15 SECTION 3. There are appropriated or authorized from the  
16 sources of funding indicated below to collective bargaining  
17 statewide (BUF 102) the following sums or so much thereof as may  
18 be necessary to fund for fiscal biennium 2015-2017 the salary



1 increases and other cost adjustments authorized by chapter 89C,  
2 Hawaii Revised Statutes, for state officers and employees who  
3 are excluded from collective bargaining and belong to the same  
4 compensation plans as those officers and employees within  
5 collective bargaining unit (11):

11 SECTION 4. Funds appropriated or authorized by this part  
12 shall be allotted by the director of finance to the appropriate  
13 state departments for expenditure in the respective fiscal year

16 SECTION 5. Salary increases and cost adjustments provided  
17 in this Act for any officer or employee whose compensation is  
18 paid, in whole or in part, from federal, special, or other funds  
19 shall be paid wholly or proportionately, as the case may be,  
20 from the respective funds.



1 SECTION 6. Funds appropriated or authorized by this Act  
2 that are not expended or encumbered by June 30, 2016, and  
3 June 30, 2017, of the respective fiscal years, shall lapse as of  
4 those dates.

5 SECTION 7. This Act shall take effect upon its approval.
