
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 187, Session Laws of Hawaii 2012, is
2 amended by amending section 3 to read as follows:

3 "SECTION 3. The University of Hawaii John A. Burns school
4 of medicine and the University of Hawaii at Manoa school of
5 nursing and dental hygiene shall implement the Hawaii health
6 corps program no later than June 30, 2013.

7 ~~[The deans of the University of Hawaii John A. Burns school
8 of medicine and the University of Hawaii at Manoa school of
9 nursing and dental hygiene shall report to the legislature on
10 the status of the Hawaii health corps program no later than
11 twenty days prior to the convening of each regular session of
12 the legislature, beginning with the regular session of 2013.]"~~

13 SECTION 2. Section 304A-1144, Hawaii Revised Statutes, is
14 repealed.

15 ~~["~~§304A-1144~~ Annual report. The office of the vice
16 president for community colleges shall prepare an annual report
17 to the legislature on the status of the program. This annual~~

 2 ~~academy curriculum and content, teaching standards throughout~~

6 SECTION 3. Section 304A-3305, Hawaii Revised Statutes, is
 7 repealed.

6 SECTION 4. Section 4 of Act 281, Session Laws of Hawaii
 7 2007, is repealed.
