SENATE CONCURRENT RESOLUTION

ENDORISING AND ADOPTING, AND URGING THE SEVERAL COUNTIES TO
ENDORSE AND USE, THE UNITED NATIONS SEVENTEEN SUSTAINABLE
DEVELOPMENT GOALS AS COMPONENTS OF A FRAMEWORK FOR
ADDRESSING AND ASSESSING HAWAII'S EFFORTS TOWARD SOCIAL
JUSTICE AND SUSTAINABILITY.

1 WHEREAS, in September 2015, the United Nations General
2 Assembly adopted the historic 2030 Development Agenda,
3 *Transforming our world: the 2030 Agenda for Sustainable*
4 *Development*, a comprehensive, creative, and courageous plan of
5 action to end poverty, protect the planet, and ensure that all
6 people enjoy peace and prosperity; and

7
8 WHEREAS, the 2030 Development Agenda includes seventeen
9 sustainable development goals and one hundred sixty-nine
10 associated targets; and

11
12 WHEREAS, the seventeen sustainable development goals are a
13 set of universal goals produced to meet the most urgent
14 environmental, political, and economic challenges of the world,
15 and build upon and replace the millennium development goals,
16 which started a global effort in 2000 to tackle the indignity of
17 poverty; and

18
19 WHEREAS, the seventeen sustainable development goals are of
20 an unprecedented scope and significance based on intensive
21 public participation and multi-country consultations over two
22 years; and

24 WHEREAS, global sustainable development cannot be realized
25 without peaceful, just, and inclusive societies that respect
26 human rights and the rule of law, and

27
28 WHEREAS, the seventeen sustainable development goals
29 promote a transformative human rights-based development agenda
30 that pledges no one will be left behind; and

2 WHEREAS, the seventeen sustainable development goals are:

38 WHEREAS, the seventeen sustainable development goals
39 provide an agenda for grassroots and global action, and
40 individuals, communities, and states must generate the political
41 will necessary to achieve the goals; and

1 WHEREAS, the world today has transformative social tools
2 and technology to achieve the sustainable development goals, and
3 success will be based on broad participation by communities
4 across the globe; and
5

6 WHEREAS, Hawaii is already involved in the campaign to
7 protect the planet and end poverty, and in December 2015, the
8 United Nations Framework Convention on Climate Change Conference
9 included the premiere of a short video production created by
10 Hawaii youth about the seventeen sustainable development goals;
11 and

13 WHEREAS, in Hawaii, college and community dialogues have
14 included discussions on the seventeen sustainable development
15 goals, and these conversations will continue to generate genuine
16 insight into how the goals are being realized in the Hawaiian
17 islands; now, therefore,
18

19 BE IT RESOLVED by the Senate of the Twenty-ninth
20 Legislature of the State of Hawaii, Regular Session of 2017, the
21 House of Representatives concurring, that the Legislature
22 engages, endorses, accepts, and adopts the United Nations
23 seventeen sustainable development goals as components of a
24 framework for addressing and assessing Hawaii's efforts toward
25 social justice and sustainability; and

27 BE IT FURTHER RESOLVED that the Legislature urges the
28 county councils to endorse and use the United Nations seventeen
29 sustainable development goals as measurements for each county's
30 efforts regarding people, peace, and the planet; and
31

32 BE IT FURTHER RESOLVED that certified copies of this
33 Concurrent Resolution be transmitted to the President of the
34 United States, Majority Leader of the United States Senate,
35 Speaker of the United States House of Representatives,
36 Secretary-General of the United Nations, Executive Secretary of
37 the United Nations Framework Convention on Climate Change,
38 United Nations High Commissioner for Human Rights, Governor of
39 the State of Hawaii, each mayor of the several counties, each
40 chairperson of the several county councils, Attorney General,
41 Chairperson of the Board of Education, Superintendent of
42 Education, Director of Health, Director of Human Services,
